BROOKVILLE MUNICIPAL COUNCIL  
REGULAR MEETING  
April 18, 1995

The regular meeting of the Brookville Municipal Council was called to order by Vice Mayor Dafler at 7:30 P.M. on April 18, 1995, in the Municipal Council Room. Members Dafler, Garber, Imler, Seagraves, Shellabarger and Trimble; Manager Wright and Law Director Stephan were present, with Mayor Duncan arriving later.

Motion by Imler, seconded by Seagraves to accept the agenda as presented with additions. All yeas, motion carried.

Motion by Seagraves, seconded by Imler to accept the April 4, 1995 regular meeting minutes as presented. All yeas, motion carried.

Fire Chief Nickel gave his report on highlights from the 1994 annual report with questions and answers on activities.

Mayor Duncan arrived.

Police Chief Papanek gave a report on highlights from the 1994 annual report with questions and answers on activities with the following action taken.

Motion by Duncan, seconded by Shellabarger to endorse the idea of creating a Task Force Committee to work on coming up with suggestions for dealing with various problems with the youth; with Manager Wright, Police Chief and Law Director Stephan to be involved. All yeas, motion carried.

Public Hearing on Zoning for Newly Annexed Property on Ordinance No. 1995-04.

Planning Commission President Watkins related the action of the Planning Commission and what the related classification would allow.

Clerk Roeser reported that the advertising was done and the office has received no comments on the zoning and no one is present for the Public Hearing except the Planning Commission members.

Vice Mayor Dafler closed the Public Hearing and called Council back into regular session.

Motion by Imler, seconded by Seagraves to read proposed Ordinance No. 1995-04. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the second reading of proposed Ordinance No. 1995-04. Garber nay, Dafler, Imler, Seagraves, Shellabarger, Trimble and Duncan; yeas. Motion carried with 1 nay and 6 yeas.

Finance Director Roeser went over some of the highlights from the 1994 annual report with questions and answers on the activities.

Manager Wright went over some of the highlights from the annual report and the activities with questions and answers.

Manager Wright gave his report with the following action taken:

Motion by Imler, seconded by Seagraves to authorize Manager Wright to exceed the \$10,000.00 (ten thousand dollars) purchasing limit if necessary for buying a used dump truck at auction. All yeas, motion carried.

Law Director Stephan gave his report with the following action taken:

Motion by Shellabarger, seconded by Seagraves to read proposed Ordinance No. 1995-05. All yeas, motion carried.

Motion by Imler, seconded by Duncan to accept the first reading and dispense with the second and third reading and adopt Ordinance No. 1995-05 entitled "AN ORDINANCE REGULATING SOUND AMPLIFICATION SYSTEMS IN MOTOR VEHICLES OPERATED IN THE MUNICIPALITY OF BROOKVILLE, OHIO AND DECLARING IT AN EMERGENCY." All yeas, motion carried.

Mayor Duncan gave his report with no action taken.


Councilman Garber requested action on school issue.

Motion by Garber, seconded by Imler to endorse the 8.5 mill school operating levy. All yeas, motion carried.


Motion by Imler, seconded by Garber to go into executive session on a real estate matter, as requested by Manager Wright. All yeas, motion carried.
