

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
June 6, 1995

The regular meeting of the Brookville Municipal Council was called to order by Mayor Duncan at 7:30 P.M. on June 6, 1995 in the Municipal Council Room. Members Dafler, Garber, Imler, Seagraves, Shellabarger and Trimble: Manager Wright and Law Director Stephan were present.

Motion by Seagraves, seconded by Dafler to accept the agenda as presented, with additions. All yeas, motion carried.

Motion by Seagraves, seconded by Dafler to accept the May 25, 1995 special meeting minutes as presented. All yeas, motion carried.

Citizen Comments: Ms. Letner inquired about reducing the speed limit on Wolf Creek Pike around Ward Park or posting "Children At Play" signs for the safety of small children in the area. Discussion followed. Consensus was to install some "Children At Play" signs and check into speeding.

Manager Wright gave his report with the following action taken:

There is a Public Meeting set up for Tuesday, June 27, 1995 at 7:00 P.M. with property owners on West Westbrook Road on extending the sanitary sewer line to Arlington Road on the north side of Westbrook Road.

Law Director Stephan gave his report with no action taken.

Finance Director Roeser gave his report with the following action taken:

Motion by Imler, seconded by Dafler to accept the May 31, 1995 Fund Balance as presented. All yeas, motion carried.

Mayor Duncan gave his report with the following action taken:

Consensus was to have the first meeting of July on Wednesday, July 5th, 1995 due to the regular meeting date of July 4 being a holiday.

Manager Wright gave his report on the C.I.C. Committee for Daycare and expressed that the C.I.C. would not proceed any more at the present time due to apparent lack of interest shown by the survey taken, but Green Tokai may proceed with some planning.

Motion by Duncan, seconded by Seagraves to go into executive session on a legal matter as requested by Councilwoman Imler. All yeas, motion carried.

Mayor Duncan called the meeting to order for a Public Hearing on Ordinance No. 1995-07 on the rezoning of property on East Upper Lewisburg-Salem Road. Planning Commission President Watkins went over the requested changes, and Clerk Roeser related that 16 letters were sent to property owners plus advertised in the Star for two weeks and have not received any objections, three property owners were present. Discussion followed. The Planning Commission will have their recommendations at the next meeting.

Mayor Duncan called Council back into regular session.

Motion by Imler, seconded by Dafler to read proposed Ordinance No. 1995-07. All yeas, motion carried.

Motion by Imler, seconded by Dafler to accept the second reading of proposed Ordinance No. 1995-07. All yeas, motion carried.

Motion by Garber, seconded by Trimble to go back into executive session to continue discussion of a legal matter. All yeas, motion carried.

Mayor Duncan called Council back into regular session.

Motion by Imler, seconded by Dafler to adjourn. All yeas, motion carried.
