

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
October 17, 1995

The regular meeting of the Brookville Municipal Council was called to order by Mayor Duncan at 7:30 P.M. on October 17, 1995 in the Municipal Council Room. Members Dafler, Garber, Imler, Seagraves, Shellabarger and Trimble; Manager Wright and Law Director Stephan were present.

Motion by Seagraves, seconded by Imler to accept the Agenda as presented with additions. All yeas, motion carried.

Motion by Dafler, seconded by Seagraves to accept the October 3, 1995 regular meeting minutes as presented. All yeas, motion carried.

Citizens Comments: Tim Schram presented plans for the Kinsel plat with the following action taken.

Motion by Imler, seconded by Seagraves to accept and approve the record plat for the Kinsel property on Hay Avenue as presented. All yeas, motion carried.

Lori Sever attended with some comments on speeding on Western Avenue and drivers not stopping at stop signs and also youth destroying property; and asked if something can be done. Discussion followed and Council will check with the Police Department.

Manager Wright gave his report with no action taken, but asked for an executive session on legal and real estate matters.

Law Director Stephan gave his report with the following action taken.

Motion by Seagraves, seconded by Imler to read proposed Ordinance No. 1995-12. All yeas, motion carried.

Motion by Imler, seconded by Dafler to accept the first reading, dispense with the second and third reading and adopt Ordinance No. 1995-12 entitled "AN ORDINANCE AMENDING CHAPTER 52 OF THE CODE OF ORDINANCES, AND DECLARING IT AN EMERGENCY". All yeas, motion carried.

Finance Director Roeser gave his report with no action taken.


Motion by Imler, seconded by Seagraves to read proposed Ordinance No. 1995-11. All yeas, motion carried.

All yeas, motion carried.

Motion by Imler, seconded by Seagraves to go into executive session concerning some real estate negotiations and legal matters. All yeas, motion carried.

Motion by Imler, seconded by Dafler to adjourn. All yeas, motion carried.
