

BROOKVILLE MUNICIPAL COUNCIL  
REGULAR MEETING  
JULY 7, 1992

The regular meeting of the Brookville Municipal Council was called to order by Mayor Duncan at 7:30 P.M. on July 7, 1992 in the Municipal Council Chambers. Members Ausra, Dafler, Garber, Imler, Seagraves and Trimble; Manager Wright and Law Director Zuhl were present.

Motion by Dafler, seconded by Imler to accept the Agenda as presented. All yeas, motion carried.

Motion by Dafler, seconded by Imler to approve the June 16, 1992 regular meeting minutes as presented. All yeas, motion carried.

Citizen Comments: Neil Mangan and a representative from the District Parks gave a presentation on Bike-Ways and answered questions concerning those.

Mayor Duncan recessed Council meeting for the Public Hearing on the 1993 Tax Budget.

Finance Director Roeser reported that one citizen came in to look over the budget and Council had received copies of budget. Went over the budget, reported that some changes were made for better reporting to other agencies, and answered questions from Council on the budget. There was no input or questions from citizens.

Motion by Duncan, seconded by Imler to accept title to the 7.3 acre Westbrook Park from Montgomery County at no cost to Brookville. All yeas, motion carried.

Finance Director Roeser gave his report with the following action taken:

Motion by Ausra, seconded by Garber to accept the June 30, 1992 Fund Balance as presented. All yeas, motion carried.

Mayor Duncan gave his report with no action taken.

Motion by Seagraves, seconded by Dafler to read proposed Ordinance No. 1992-09. All yeas, motion carried.


Motion by Dafler, seconded by Seagraves to accept the first reading of proposed Ordinance No. 1992-09. All yeas, motion carried.
