

BROOKVILLE MUNICIPAL COUNCIL  
REGULAR MEETING  
MARCH 17, 1992

The regular meeting of the Brookville Municipal Council was called to order by Mayor Duncan at 7:30 P.M. on March 17, 1992 in the Municipal Council Chambers. Members Ausra, Dafler, Garber, Imler, Seagraves and Trimble; Manager Wright and Law Director Zuhl were present.

Motion by Imler, seconded by Seagraves to accept the Agenda as presented. All yeas, motion carried.

Motion by Seagraves, seconded by Dafler to approve the March 3, 1992 regular meeting minutes as presented. All yeas, motion carried.

Citizens Comments: Mr. & Mrs. Britton stated that they were opposed to their property being included in the proposed annexation that was filed. Discussion followed.

Manager Wright gave his report including an update on curbside recycling and discussed grass clipping. He asked for an executive session concerning real estate, mainly on the railroad property being abandoned.

Finance Director Roeser gave his report with the following action taken:

Motion by Garber, seconded by Imler to authorize entering into a contract (for grant of \$2,500) with the Brookville Historical Society for 1992. All yeas motion carried.

Mayor Duncan gave his report with the following action taken:

Motion by Imler, seconded by Trimble to read proposed Resolution No. 92-10. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the first reading, dispense with the second and third reading and adopt Resolution No. 92-10 entitled "A RESOLUTION OF SUPPORT TO PETITION GEORGE BUSH, PRESIDENT OF THE UNITED STATES, TO SUSPEND ALL ACTIVITIES BY THE DEPARTMENT OF ENERGY REGARDING THE RECONFIGURATION OF THE NUCLEAR WEAPONS COMPLEX UNTIL A COMPLETE REVIEW OF DOE CONSOLIDATION PLANS IS COMPLETED AND DECLARING IT AN EMERGENCY". Garber nay; Ausra, Dafler, Duncan, Imler, Seagraves and Trimble yeas, motion carried with 6 yeas and 1 nay.

Motion by Imler, seconded by Seagraves to read proposed Ordinance No. 1992-06. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the first reading of proposed Ordinance No. 1992-06. All yeas, motion carried.
