

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
SEPTEMBER 15, 1992

The regular meeting of the Brookville Municipal Council was called to order by Mayor Duncan at 7:30 P.M. on September 15, 1992 in the Municipal Council Chambers. Members Ausra, Dafler, Garber, Seagraves and Trimble; and Manager Wright were present. Member Imler and Law Director Zuhl were absent.

Motion by Seagraves, seconded by Dafler to accept the Agenda as presented with additions. All yeas, motion carried.

Motion by Dafler, seconded by Seagraves to approve the September 1, 1992 regular meeting minutes as presented. All yeas, motion carried.

Citizens Comments: 1) Al Fullenkamp, candidate for County Engineer, gave a short presentation on his background and the office.

2) Barb Ohler, citizen on Hill Street, gave a presentation on a request for Council to make Hill Street and McKinley Street intersection a "3 Way Stop" to slow traffic down for safety. Discussion followed.

3) Dottie Watkins commented on bike riders going on the wrong side of the street and that adults were also offenders. Discussion followed.

Manager Wright gave his report with the following action taken:

Motion by Garber, seconded by Trimble to accept the low bid of \$22,970 from Norco Equipment Company as the best bid for a new air compressor system which is recommended by the Fire Chief and Manager. All yeas, motion carried.

Motion by Seagraves, seconded by Dafler to accept the low bid of \$116,037 from R.B. Jergens Contractor as the best bid for Wright Avenue Extension Project as recommended by the Manager. All yeas, motion carried.

Motion by Seagraves, seconded by Trimble to read proposed Ordinance No. 1992-13. All yeas, motion carried.

Motion by Dafler, seconded by Seagraves to accept the first reading, dispense with the second and third reading and adopt Ordinance No. 1992-13 entitled "AN ORDINANCE PROHIBITING THE PARKING OF VEHICLES ONE TON OR OVER IN SIZE FROM PARKING IN ANY MUNICIPAL OWNED PUBLIC PARKING LOT AND DECLARING IT AN EMERGENCY". All yeas, motion carried.

Mayor Duncan gave his report with the following action taken:

Motion by Duncan, seconded by Garber to sell tapes of the President's Visit to citizens at \$6.00 per tape. All yeas, motion carried.

Motion by Garber, seconded by Seagraves to read proposed Ordinance No. 1992-11. All yeas, motion carried.

Motion by Seagraves, seconded by Garber to accept the third reading and adopt Ordinance No. 1992-11 entitled "AN ORDINANCE AMENDING THE CODE OF ORDINANCES TITLE 5, SECTION 50.30, PARAGRAPH A - AN ORDINANCE FIXING THE RATES AND CHARGES TO ALL WATER CONSUMERS AND SECTION 50.09 FIXING THE TAPPING PERMIT FEES IN THE MUNICIPALITY OF BROOKVILLE, OHIO". All yeas, motion carried.

Motion by Seagraves, seconded by Dafler to read proposed Resolutions Nos. 92-17 and 92-18. All yeas, motion carried.

Motion by Seagraves, seconded by Trimble to accept the second reading of proposed Resolutions Nos. 92-17 and 92-18. All yeas, motion carried.

Motion by Seagraves, seconded by Garber to appoint Member Dafler as Council representative to serve on the building committee for the Community Theatre project. All yeas, motion carried.

Motion by Seagraves, seconded by Garber to adjourn. All yeas, motion carried.
