

BROOKVILLE MUNICIPAL COUNCIL  
REGULAR MEETING  
FEBRUARY 5, 1991

The regular meeting of the Brookville Municipal Council was called to order by Mayor Duncan at 7:30 P.M. on February 5, 1991 in the Municipal Council Chambers. Members Ausra, Dafler, Garber, Imler and Seagraves; Manager Wright were present with Director of Law Zuhl arriving later. Member McCauley was absent.

Motion by Seagraves, seconded by Dafler to accept the Agenda as presented with addition. All yeas, motion carried.

Motion by Imler, seconded by Dafler to approve the January 15, 1991 regular meeting minutes as presented. All yeas, motion carried.

Citizen Comments: Dottie Watkins requested a \$2,500.00 grant from the Municipality for the Brookville Historical Society.

Motion by Ausra, seconded by Seagraves to grant the request for \$2,500. for the Brookville Historical Society with a contract for the funds to be prepared. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to authorize the purchase of property at the northwest corner of Main and Walnut Streets at a price of \$8,500.00 for use in extending the Wolf Creek Sanitary Sewer Trunk Line Project. All yeas, motion carried.

Motion by Seagraves, seconded by Imler to read proposed Resolution No. 91-09. All yeas, motion carried.

Motion by Imler, seconded by Dafler to accept the first reading, dispense with the second and third reading and adopt Resolution No. 91-09 entitled "A RESOLUTION AUTHORIZING THE FINANCE DIRECTOR OF THE MUNICIPALITY OF BROOKVILLE, OHIO TO CONTINUE PAYING SALARIES TO THE POLICE OFFICERS OF THE MUNICIPALITY OF BROOKVILLE, OHIO PENDING CONTRACT SETTLEMENT AND DECLARING IT AN EMERGENCY".
