

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
APRIL 17, 1990

The regular meeting of the Brookville Municipal Council was called to order by Mayor Duncan at 7:30 P.M. on April 17, 1990 in the Municipal Council Chambers. Members Ausra, Dafler, Garber, Imler and Seagraves; Manager Wright and Law Director Zuhl were present. Member McCauley was absent.

Motion by Seagraves, seconded by Imler to accept the Agenda as presented with deletions. All yeas, motion carried.

Motion by Imler, seconded by Dafler to approve the April 3, 1990 regular meeting minutes as presented. All yeas, motion carried.

Citizens Comments: Mary Wright with the School Citizen Committee gave a presentation and handed out literature regarding information concerning the School Tax Issue.

Manager Wright gave his report with the following action taken:

Motion by Duncan, seconded by Garber to authorize Manager Wright to proceed with having the Stanhope Building on Baker Street torn down when everything is in order as far as the Municipal's ownership of the property. All yeas, motion carried.

Motion by Seagraves, seconded by Imler to accept the plans and specifications as presented for construction on the Carr Drive extension to Westbrook Road. All yeas, motion carried.

Finance Director Roeser gave his report with the following action taken:

Motion by Garber, seconded by Imler to authorize and approve the parade route for the Brookville Teacher's Association on April 28, 1990 as requested. All yeas, motion carried.

Mayor Duncan gave his report with no action taken.

Motion by Duncan, seconded by Garber to amend proposed Ordinance No. 1990-01 to three (3) hours parking restriction instead of one (1) hour restriction in Section I. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to read proposed Ordinance No. 1990-01 as amended. All yeas, motion carried.

Motion by Imler, seconded by Dafler to accept the first reading, dispense with the second and third reading and adopt Ordinance No. 1990-01 entitled "AN ORDINANCE AMENDING SECTION 76.08 OF THE CODE OF ORDINANCE OF THE MUNICIPALITY OF BROOKVILLE BY ADDITION OF THREE (3) HOURS RESTRICTED PARKING AREA PLUS AMENDING THE PENALTY CHARGE FOR PARKING VIOLATIONS AND DECLARING IT AN EMERGENCY". Ausra nay; Dafler, Duncan, Garber, Imler and Seagraves yeas, motion carried with 5 yeas and 1 nay.

Motion by Imler, seconded by Seagraves to read proposed Resolution No. 90-10. All yeas, motion carried.

Motion by Imler, seconded by Dafler to accept the first reading, dispense with the second and third reading and adopt Resolution No. 90-10 entitled "A RESOLUTION DECLARING THE NECESSITY CONSTRUCTING, PLACING AND REPAIRING CERTAIN SIDEWALKS AND CURBS IN THE MUNICIPALITY OF BROOKVILLE, OHIO, REQUIRING ABUTTING PROPERTY OWNERS TO CONSTRUCT, REPAIR AND REPLACE THE SAME AND DECLARING IT AN EMERGENCY". Ausra nay; Dafler, Duncan, Garber, Imler and Seagraves yeas, motion carried with 5 yeas and 1 nay.

Motion by Imler, seconded by Seagraves to adjourn. All yeas, motion carried.
