

BROOKVILLE MUNICIPAL COUNCIL  
REGULAR MEETING  
JUNE 5, 1990

The regular meeting of the Brookville Municipal Council was called to order by Mayor Duncan at 7:30 P.M. on June 5, 1990 in the Municipal Council Chambers. Members Ausra, Dafler, Garber, Imler, McCauley and Seagraves; Manager Wright and Law Director Zuhl were present.

Motion by Seagraves, seconded by Imler to accept the Agenda as presented. All yeas, motion carried.

Motion by Imler, seconded by Dafler to approve the May 29, 1990 continuation of the regular meeting minutes as presented. All yeas, motion carried.

**Citizen Comments:** Dottie Watkins of the Planning Commission gave their recommendation that Council adopt legislation requiring all surveys performed in Brookville be filed with the Municipality.

Motion by Imler, seconded by Ausra to have legislation drafted requiring all survey work performed in Brookville be filed with the Municipality. All yeas, motion carried.

Manager Wright gave his report with the following action taken:

Motion by Imler, seconded by Garber to draft an ordinance for "No Parking" on Arlington Road between N. Wolf Creek Street and Arlington Road intersection to the north side of Arlington Arms Apartments. All yeas, motion carried.

Finance Director Roeser gave his report with the following action taken:

Motion by Seagraves, seconded by Dafler to accept the May 31, 1990 Fund Balance as presented. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to waive the hearing before the Montgomery County Budget Commission on the 1991 Tax Budget. All yeas, motion carried.

Mayor Duncan gave his report with no action taken.

Motion by Imler, seconded by Seagraves to read proposed Resolution No. 90-09. All yeas, motion carried.

Motion by Dafler, seconded by Imler to accept the third reading and adopt Resolution No. 90-09 entitled "A RESOLUTION ESTABLISHING THE COMPENSATION OF THE VOLUNTEER FIRE AND AMBULANCE PERSONNEL". All yeas, motion carried.

Motion by Seagraves, seconded by Imler to read proposed Resolution No. 90-11. All yeas, motion carried.

Motion by Imler, seconded by Duncan to accept the second reading of proposed Resolution No. 90-11. Seagraves nay; Ausra, Dafler, Duncan, Garber, Imler and McCauley yeas, motion carried with 5 yeas and 1 nay.

Motion by Duncan, seconded by Seagraves to read proposed Ordinance No. 1990-03. All yeas, motion carried.

Motion by Imler, seconded by Dafler to accept the second reading of proposed Ordinance No. 1990-03. Garber nay; Ausra, Dafler, Duncan, Imler, McCauley and Seagraves yeas, motion carried with 6 yeas and 1 nay.

Motion by Duncan, seconded by Imler to read proposed Ordinance No. 1990-04. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the second reading of proposed Ordinance No. 1990-04. All yeas, motion carried.

Motion by Seagraves to read proposed Ordinance No. 1990-05. There was no second and proposed Ordinance No. 1990-04 died due to the lack of a second.

Motion by Imler, seconded by Seagraves to adjourn. All yeas, motion carried.
