

BROOKVILLE MUNICIPAL COUNCIL  
REGULAR MEETING  
MARCH 20, 1990

The regular meeting of the Brookville Municipal Council was called to order by Mayor Duncan at 7:30 P.M. on March 20, 1990 in the Municipal Council Chambers. Members Ausra, Dafler, Garber, Imler, McCauley and Seagraves; and Manager Wright were present. Law Director Zuhl was absent.

Motion by Dafler, seconded by Seagraves to accept the Agenda as presented. All yeas, motion carried.

Motion by Imler, seconded by Dafler to approve the March 6, 1990 regular meeting minutes as presented. All yeas, motion carried.

Citizens Comments: Dorothy Watkins requested a \$2,500.00 grant from the Municipality for the Brookville Historical Society.

Motion by Imler, seconded by Ausra to grant the request for \$2,500.00 for the Brookville Historical Society with a contract for the 1990 funds to be prepared. All yeas, motion carried.

Manager Wright gave his report with the following action taken:

Motion by Imler, seconded by Seagraves to accept the O'Brien Sewer Equipment Co. bid of \$15,391.00 for a sewer jetter which was the lowest and best bid as recommended by the Manager. All yeas, motion carried.

Motion by Seagraves, seconded by Imler to accept the Bobcat bid of \$12,954.00 for a skid loader and auger which was recommended as the best bid due to immediate delivery and availability of attachments to rent for it locally. All yeas, motion carried.

Steve Stanley with Miami Valley Art Council arrived and gave a presentation on grants available that could be applied for through the Art Council. Discussion was held and no action was taken.

Manager Wright's report continued:

Motion by Dafler, seconded by Imler to accept the State bid of \$17,398 for a four wheel drive, four door for the Fire Chief's vehicle which was the lowest bid and recommended by the Manager. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the low bid on water line materials as per itemized low price per item from Treaty, Price Brothers, Ohio Material Water Supply amounting to \$34,384.00 as recommended by the Manager. All yeas, motion carried.

Motion by Duncan, seconded by McCauley to accept the offer of \$100,000 loan at zero interest for twenty years from the Issue II Program for Sanitary Sewer Trunk Line Project that was submitted. Garber nay; Ausra, Dafler, Duncan, Imler, McCauley and Seagraves yeas, motion carried with a vote of 6 yeas and 1 nay.

Motion by Imler, seconded by Duncan to prepare an ordinance for "One Hour Parking" at four spaces on Market Street east of the railroad on the north side, also increase fine on violation of parking limitation to \$5.00

within 24 hours of the issuance and \$10.00 if after 24 hours of issuance, but before 72 hours. Garber nay; Ausra, Dafler, Duncan, Imler, McCauley and Seagraves yeas, motion carried with 6 yeas and 1 nay.

Mayor Duncan gave his report with the following action taken:

Motion by Dafler, seconded by Imler to approve May 24, 25, 29 and 30, 1990 for Youth-In-Government with the May 15th regular Council meeting to be recessed and be moved to the High School auditorium for Youth-In-Government's council meeting on May 29, 1990 at 7:30 P.M. and to finish the regular Council meeting. All yeas, motion carried.

Motion by Dafler, seconded by Duncan to authorize having the Summer Play-ground Program from Montgomery County for seven weeks at a cost of \$2,205 at Golden Gate Park. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to adjourn. All yeas, motion carried.
