

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
SEPTEMBER 4, 1990

The regular meeting of the Brookville Municipal Council was called to order by Mayor Duncan at 7:30 P.M. on September 4, 1990 in the Municipal Council Chambers. Members Ausra, Dafler, Imler, McCauley and Seagraves were present with Member Garber and Manager Wright arriving later. Law Director Zuhl was absent.

Motion by Seagraves, seconded by Dafler to accept the Agenda as presented. All yeas, motion carried.

Motion by Imler, seconded by Dafler to approve the August 21, 1990 regular meeting minutes as presented. All yeas, motion carried.

Citizen Comment: Robert Bausman requested that the sanitary sewer line on E. Westbrook Road be extended to his property. Discussion followed and the matter will be looked into.

Robert Apgar requested that it be looked into for a possible stop sign on Albert Road at the railroad track on the east side for the northbound traffic for safety factor for the Cusick and Carr Drive intersection.

Finance Director Roeser gave his report with the following action taken:

Motion by Imler, seconded by Seagraves to approve blocking off Vine Street from Wall Street to Salem Street from 3:00 to 6:30 P.M. on September 8, 1990 for a block party. All yeas, motion carried.

Member Garber and Manager Wright arrived.

Manager Wright gave his report with the following action taken:

Motion by Imler, seconded by Seagraves to post signs on one side of March Avenue and Clay Street near the football field as a "no parking" and a "tow-away zone" on Friday night for home football games. All yeas, motion carried.

Motion by Seagraves, seconded by Duncan to authorize accepting the loan of \$100,000 from the Issue II fund for the Sanitary Sewer Trunk Line Extension. Garber nay; Ausra, Dafler, Duncan, Imler, McCauley and Seagraves yeas, motion carried with 6 yeas and 1 nay.

Discussion held on the Census report that was received.

Motion by Garber, seconded by Imler to accept the Census Report as received. Duncan and McCauley nays; Ausra, Dafler, Garber, Imler and Seagraves yeas, motion carried with 5 yeas and 2 nays.

Mayor Duncan gave his report with no action taken.

Motion by Imler, seconded by Seagraves to read proposed Resolution No. 90-16. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the third reading and adopt Resolution No. 90-16 entitled "A RESOLUTION INTENDED TO ENSURE MUNICIPALITY OF BROOKVILLES' COMPLIANCE WITH THE DRUG-FREE WORKPLACE ACT OF 1988, AND THAT EMPLOYEES HAVE THE RIGHT TO EXPECT A DRUG-FREE PLACE IN WHICH TO WORK". All yeas, motion carried.

Motion by Seagraves, seconded by Imler to read proposed Ordinance 1990-09. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the first reading of proposed Ordinance No. 1990-09. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to adjourn. All yeas, motion carried.
