

BROOKVILLE MUNICIPAL COUNCIL  
REGULAR MEETING  
APRIL 18, 1989

The regular meeting of the Brookville Municipal Council was called to order by Mayor Duncan at 7:30 P.M. on April 18, 1989 in the Municipal Council Chambers. Members Ausra, Dafler, Imler, Keener and Seagraves; Manager Wright and Law Director Zuhl were present. Member Garber and Clerk Roeser were absent with Manager Wright as acting clerk.

Motion by Seagraves, seconded by Dafler to accept the Agenda as presented. All yeas, motion carried.

Motion by Imler, seconded by Dafler to approve the April 4, 1989 regular meeting minutes as presented. All yeas, motion carried.

Citizens Comments: Bob Kuck inquired as to whether the Heney case against Brookville had been settled. Discussion followed.

Request was made by Tom Dafler to change the date of the High School Band Concert to May 18, 1989.

Motion by Imler, seconded by Seagraves to change the Band Concert date from May 20, 1989 to May 18, 1989 that is to be held in front of the high school. All yeas, motion carried.

Manager Wright gave his report on the following:

- a) Triggs Road Project - Construction to start in a week or two.
- b) Meet with the property owners in reference to the Albert Road Project.
- c) Grass reduction plan to be implemented in refuse routes within village.
- d) Fact Finder's report was received on April 17, 1989.
- e) Explained the situation concerning the shelters at Golden Gate Park.

Council recessed for the Public Hearing at 8:00 P.M. on the zoning of the newly annexed area of Mosier's. Discussion and questions period was held with no opposition stated.

Mayor Duncan called Council back to order at 8:15 P.M.


Motion by Seagraves, seconded by Imler to read proposed Ordinance No. 1989-07. All yeas, motion carried.

Motion by Imler, seconded by Dafler to accept the third reading and adopt Ordinance No. 1989-07 entitled "AN ORDINANCE ZONING CERTAIN LOTS OF THE REVISED CONSECUTIVE NUMBER OF LOTS OF THE MUNICIPALITY OF BROOKVILLE, OHIO TO A NEW CLASSIFICATION OF "I-2" as recommended by the Planning Commission. All yeas, motion carried.

Motion by Imler, seconded by Dafler to go into executive session to discuss personnel. All yeas, motion carried.

Council returned from session at 9:40 P.M. Mayor Duncan set Special Council Meeting for Friday, April 21, 1989 at 7:30 P.M. to act on the fact-finder's report.
