

BROOKVILLE MUNICIPAL COUNCIL  
REGULAR MEETING  
JULY 18, 1989

The regular meeting of the Brookville Municipal Council was called to order by Mayor Duncan at 7:30 P.M. on July 18, 1989 in the Municipal Council Chambers. Members Ausra, Dafler, Garber, Imler, Keener and Seagraves; and Law Director Zuhl were present. Manager Wright was absent.

Motion by Seagraves, seconded by Dafler to accept the Agenda as presented. All yeas, motion carried.

Motion by Imler, seconded by Dafler to approve the July 5, 1989 regular meeting minutes as presented. All yeas, motion carried.

Citizen Comments: Request was made from a citizen on E. Westbrook Road concerned with the speeding on Westbrook Road and for safety reasons speed limit needs to be enforced more. Discussion followed.

Clerk Roeser gave Manager Wright's report with the following action taken:

Motion by Imler, seconded by Ausra to authorize advertising for bids on the 1989 regular street re-surfacing program. All yeas, motion carried.

Finance Director Roeser gave his report with the following action taken:

Motion by Imler, seconded by Ausra to waive the hearing on the "1990" Annual Tax Budget before the Montgomery County Budget Commission. All yeas, motion carried.

Motion by Ausra, seconded by Imler to accept the June 30, 1989 Fund Balance as presented. All yeas, motion carried.

Motion by Seagraves, seconded by Dafler to stop taking names for the proposed Property Maintenance Committee as there are ten interested persons already. Garber nay; Ausra, Dafler, Duncan, Imler, Keener and Seagraves yeas, motion carried with 6 yeas and 1 nay.

Discussion held on the time to interview those interested in the Committee. No action was taken.

Mayor Duncan gave his report with no action taken.

Mayor Duncan gave a report on the Recreation Committee with no action taken.

Discussion held on proposed Ordinance No. 1989-12.

Motion by Imler, seconded by Garber to read proposed Ordinance No. 1989-12. Keener and Ausra nay; Dafler, Duncan, Garber, Imler and Seagraves yeas, motion carried with 5 yeas and 2 nays.

Motion by Imler, seconded by Seagraves to accept the first read, dispense with the second and third reading and adopt Ordinance No. 1989-12 entitled "AN ORDINANCE AMENDING SECTION 92.30 OF THE MUNICIPAL CODE OF ORDINANCES OF BROOKVILLE, OHIO, BY AMENDING THE DEFINITION OF JUNK AND DECLARING IT AN EMERGENCY". Keener and Ausra nay; Dafler, Duncan, Garber, Imler and Seagraves yeas, motion carried with 5 yeas and 2 nays.

Motion by Imler, seconded by Keener to adjourn.
