

BROOKVILLE MUNICIPAL COUNCIL  
REGULAR MEETING  
APRIL 5, 1988

The regular meeting of the Brookville Municipal Council was called to order by Mayor Brown at 7:30 P.M. on April 5, 1988 in the Municipal Council Chambers. Members Ausra, Dafler, Duncan, Garber, Imler and Keener; Manager Wright, Law Director Zuhl and Police Director Papanek were present.

Motion by Duncan, seconded by Imler to accept the Agenda as presented. All yeas, motion carried.

Motion by Imler, seconded by Duncan to approve the March 15, 1988 regular meeting minutes as presented. All yeas, motion carried.

Citizen Comments: Phyllis Fletcher made comments on their committee that is still working on a living memorial for Dr. C. W. Thomas. Discussion followed, but no action was taken.

Tom Kewgler from the Office of Consumers Counsel gave a presentation on opposing GTE proposed rate increase and asked for Council and citizen input at a public hearing. GTE representatives, Clark and Ryland, gave a presentation on their service; facts on their commitment to Brookville and area and their community service projects. Discussion and questions followed with no actions taken.

Manager Wright gave his report with the following action taken.

Motion by Imler, seconded by Garber to read proposed Ordinance No. 1988-02. All yeas, motion carried.

Motion by Imler, seconded by Ausra to accept the first reading of proposed Ordinance No. 1988-02. All yeas, motion carried.

Public Hearing on rezoning the Hicks Farm set for May 3, 1988 at 8:00 P.M.

Manager Wright asked Police Director Papanek to give a presentation on the Montgomery County Task Force on Drug Enforcement as proposed and recommendation as to whether Brookville should join. Discussion followed.

Motion by Ausra, seconded by Duncan to authorize drafting a Resolution prepared for next meeting on joining and supporting the Task Force on Drug Enforcement. All yeas, motion carried.

Motion by Imler, seconded by Duncan to authorize proceeding with the engineering and advertising for bids on Triggs Road project. All yeas, motion carried.

Motion by Duncan, seconded by Imler to authorize proceeding with the engineering and advertising for bids on the McKinley Street project Phase I with option on Phase II. Keener nay; Ausra, Brown, Dafler, Duncan, Garber and Imler yeas, motion carried with 6 yeas and 1 nay.

Motion by Imler, seconded by Duncan to proceed with engineering and apply for premissive license tax money from the County for Albert Road Project from Cusick to Hay Avenue. All yeas, motion carried.

Finance Director Roeser gave his report with the following action taken.

Motion by Imler, seconded by Keener to accept the Fund Balance for March 31, 1988 as presented. All yeas, motion carried.

Motion by Imler, seconded by Duncan to read proposed Ordinance No. 1988-01. All yeas, motion carried.

Motion by Duncan, seconded by Imler to accept the first reading, dispense with the second and third reading and adopt Ordinance No. 1988-01 entitled "AN ORDINANCE TO ACCEPT THE APPLICATION FOR THE ANNEXATION OF CERTAIN TERRITORY CONTAINING 21.98 ACRES MORE OR LESS IN PERRY TOWNSHIP TO THE MUNICIPALITY OF BROOKVILLE, OHIO AND DECLARING AN EMERGENCY." All yeas, motion carried.

Bob Thomas spoke to Council concerning ideas people were coming up with to honor his father Dr. Thomas. No action taken.

Motion by Imler, seconded by Duncan to adjourn. All yeas, motion carried.
