

BROOKVILLE MUNICIPAL COUNCIL  
REGULAR MEETING  
AUGUST 02, 1988

The regular meeting of the Brookville Municipal Council was called to order by Mayor Brown at 7:30 P.M. on August 2, 1988 in the Municipal Council Chambers. Members Ausra, Dafler and Duncan; Manager Wright and Law Director Zuhl were present with Members Garber and Keener arriving late. Member Imler was absent.

Motion by Duncan, seconded by Dafler to accept the Agenda as presented. All yeas, motion carried.

Motion by Duncan, seconded by Dafler to approve the July 19, 1988 regular meeting minutes as presented. All yeas, motion carried.

Citizen Comments: Dorothy Watkins, on behalf of the Chamber of Commerce, reported on the Community Picnic and thanked all Municipal Officials, departments and employees.

Manager Wright gave his report with no action taken.

Reported on the sidewalk program, discussion followed. Also reported on the refuse dumping that Brookville will have to find a new place to dump trash as the Preble County Landfill will be closing out all out of county haulers. Discussion followed and will have more information next meeting.

Motion by Duncan, seconded by Dafler to read proposed Ordinances Nos. 1988-05, 1988-07 and 1988-08. All yeas, motion carried.

Motion by Duncan, seconded by Ausra to accept the second reading of proposed Ordinances Nos. 1988-05, 1988-07 and 1988-08. All yeas, motion carried.

Motion by Duncan, seconded by Dafler to read proposed Resolution No. 88-23. All yeas, motion carried.

Motion by Duncan, seconded by Dafler to accept the second reading of proposed Resolution No. 88-23. All yeas, motion carried.


Member Keener arrived.
