

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
JULY 21, 1987

The regular meeting of the Brookville Municipal Council was called to order by Mayor Brown at 7:30 P.M. on July 21, 1987 in the Municipal Council Chambers. Members Ausra, Duncan, Garber, Imler, Keener and Seagraves; Manager Wright and Law Director Zuhl were present.

Motion by Seagraves, seconded by Imler to accept the agenda as presented with the additions. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to approve the July 7, 1987 regular meeting minutes as presented. All yeas, motion carried.

Citizens comments made with the following action taken.

Motion by Duncan, seconded by Imler to approve the parade route from the V.F.W. Post to Golden Gate Park on September 12, 1987 starting at 9:00 A.M. for the Brookville Soccer Asso. as requested. All yeas, motion carried.

Manager Wright gave his report with the following action taken.

Motion by Ausra, seconded by Imler to authorize Majestic Nursery Co. to landscape the island at the Wolf Creek-Arlington Road intersection including maintaining the landscaping and having a small suitable sign with their name displayed. All yeas, motion carried.

Work Session set to follow Council meeting.

Motion by Imler, seconded by Duncan to approve the plans and specifications for Hay Avenue curb and sidewalk improvement project as presented. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to read proposed Resolution No. 87-17. All yeas, motion carried.

Motion by Duncan, seconded by Imler to accept the second reading of proposed Resolution No. 87-17. All nays, motion failed.

Motion by Imler, seconded by Duncan to read proposed Resolution No. 87-18. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the first reading, dispense with the second and third reading and adopt Resolution No. 87-18 entitled "A RESOLUTION DECLARING THE NECESSITY CONSTRUCTING, PLACING AND PREPARING CERTAIN SIDEWALKS AND CURBS IN THE MUNICIPALITY OF BROOKVILLE, OHIO, REQUIRING ABUTTING PROPERTY OWNERS TO CONSTRUCT, REPAIR AND REPLACE THE SAME AND DECLARING AN EMERGENCY". All yeas, motion carried.

Member Duncan gave a report on the Summer Playground Program.

Motion by Duncan, seconded by Ausra to amend proposed Ordinance No. 1987-05 by amending and modifying Section I of said ordinance by providing that the zoning ordinance not be codified and by addition of Section VI regarding acceptance of the recommended action of the Planning Commission with regard to zoning district changes and Section VII regarding authorization of deleting from the Code of Ordinances and other ordinance regarding land use planning, but deleting only these ordinances as set forth in Section IV of this ordinance. All yeas, motion carried.

Motion by Ausra, seconded by Seagraves to read proposed Ordinance No. 1987-05 as amended. All yeas, motion carried.

Motion by Keener, seconded by Imler to accept the second reading of proposed Ordinance No. 1987-05 as amended. All yeas, motion carried.

Motion by Duncan, seconded by Seagraves to read proposed Ordinance No. 1987-06. All yeas, motion carried.

Motion by Seagraves, seconded by Duncan to accept the third reading and adopt Ordinance No. 1987-06 entitled "AN ORDINANCE LEVYING SPECIAL ASSESSMENTS FOR THE CONSTRUCTION, REPAIR, AND REPLACEMENT OF SIDEWALKS AND CURBS IN THE VILLAGE OF BROOKVILLE, OHIO. All yeas, motion carried.
