

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
JUNE 16, 1987

The regular meeting of the Brookville Municipal Council was called to order by Vice Mayor Imler at 7:30 P.M. on June 16, 1987 in the Municipal Council Chambers. Members Ausra, Duncan, Garber, Imler, Keener, and Seagraves; Manager Wright and Law Director Zuhl were present. Mayor Brown was absent.

Motion by Seagraves, seconded by Ausra to accept the Agenda as presented with additions. All yeas, motion carried.

Motion by Duncan, seconded by Seagraves to approve the June 2, 1987 regular meeting minutes as presented. All yeas, motion carried.

Citizens Comments: The following action was taken.

Motion by Duncan, seconded by Keener to approve the route as requested by The Grace Brethren Church for June 20, 1987 from 9:30 A.M. to 11:30 A.M. for parade promoting their Bible school. All yeas, motion carried.

Manager Wright gave his report with the following action taken.

Motion by Seagraves, seconded by Duncan to authorize advertising for bids on waste water treatment plant improvement project. All yeas, motion carried.

Motion by Duncan, seconded by Seagraves to authorize advertising for bids on yearly resurfacing program to consist of overlay, slurry seal and grinding. All yeas, motion carried.

Motion by Seagraves, seconded by Ausra to authorize the Manager to contract out part of project at intersection of Arlington Road and Wolf Creek such as paving without formal bidding process due to hardship of closing down the intersection as no by-pass is available in the area, could hurt business in the area, time of doing the job extended, safety hazard with pavement torn up, difficult to come up with specs for the job due to city crew doing most of the work and time element of working together in order to keep intersection open for traffic. All yeas, motion carried.

Council recessed for Public Hearing on Ordinance No. 1987-05 new zoning ordinance and maps proposed. There were four citizens present with no objections voiced, no letters received and no objection received through the office or Council members. Discussion held on how advertiings was done and how maps have been posted for several weeks. Discussion held on whether it should be codified or Zoning Ordinance stand as a separate ordinance outside the codification which was the consensus of Council.

Council was called back to order and the Planning Commission will give Council their recommendation at the next Council meeting.

Finance Director Roeser gave his report with the following action taken.

Motion by Seagraves, seconded by Duncan to authorize paying the expense related to the undercover investigation and raid conducted by the Police Department just concluded, that includes three \$2000.00 notes signed for at the Brookville National Bank. All yeas, motion carried.

Public Hearing set for July 7, 1987 at 8:00 P.M. for the 1988 Budget.

Member Duncan reported on Recreation Committee's teen dance and also the Montgomery County Recreation Program just starting.

Motion by Seagraves, seconded by Duncan to read proposed Ordinance No. 1987-06. All yeas, motion carried.

Motion by Duncan, seconded by Seagraves to accept the first reading of proposed Ordinance No. 1987-06. All yeas, motion carried.

Motion by Duncan, seconded by Seagraves to adjourn. All yeas, motion carried.
