

BROOKVILLE MUNICIPAL COUNCIL  
REGULAR MEETING  
NOVEMBER 17, 1987

The regular meeting of the Brookville Municipal Council was called to order by Mayor Brown at 7:40 P.M. on November 17, 1987 in the Municipal Council Chambers. Members Duncan, Garber, Imler, Keener and Seagraves; Manager Wright and Law Director Zuhl were present. Member Ausra was absent.

Motion by Duncan, seconded by Imler to accept the Agenda as presented with additions. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to approve the November 3, 1987 regular meeting minutes as presented. All yeas, motion carried.

Citizen Comments: Action was taken on Green Tokai Company project that was approved by Brookville C.I.C. and certified to Council.

Motion by Seagraves, seconded by Imler to read proposed Resolution No. 87-25. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the first reading, dispense with the second and third reading and adopt Resolution No. 87-25 entitled "A RESOLUTION AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH GREEN TOKAI CO., LTD. AND DECLARING AN EMERGENCY PERTAINING TO THE FINANCING OF A MANUFACTURING FACILITY WITHIN BOUNDARIES OF THE MUNICIPALITY OF BROOKVILLE TO BE OWNED BY GREEN TOKAI CO., LTD." All yeas, motion carried.

Motion by Imler, seconded by Duncan to accept the first reading, dispense with the second and third reading and adopt Resolution No. 87-23 entitled "A RESOLUTION AUTHORIZING THE DIRECTOR OF FINANCE TO ADVERTISE FOR BIDS FOR DEPOSITORY OF PUBLIC FUNDS AND DECLARING AN EMERGENCY." All yeas, motion carried.

Motion by Duncan, seconded by Seagraves to read proposed Resolution No. 87-24. All yeas, motion carried.

Motion by Duncan, seconded by Imler to accept the first reading, dispense with the second and third reading and adopt Resolution No. 87-24 entitled "A RESOLUTION APPROVING AN ALTERNATIVE METHOD OF APPORTIONING THE UNDIVIDED LOCAL GOVERNMENT FUNDS OF MONTGOMERY COUNTY, REPEALING PRIOR APPROVALS OF OTHER ALTERNATIVE METHODS OF APPORTIONING THE UNDIVIDED LOCAL GOVERNMENT FUNDS OF MONTGOMERY COUNTY, REQUESTING THE MONTGOMERY COUNTY BUDGET COMMISSION TO PROVIDE FOR THE APPROVED ALTERNATIVE METHOD OF APPORTIONING THE UNDIVIDED LOCAL GOVERNMENT FUNDS OF MONTGOMERY COUNTY, AND DECLARING AN EMERGENCY." All yeas, motion carried.

Finance Direction Roeser gave his report with the following action taken.

Motion by Imler, seconded by Duncan to accept the October 31, 1987 Fund Balance as presented. All yeas, motion carried.

Motion by Seagraves, seconded by Duncan to pay the 1988 membership dues of \$576.00 to the Ohio Municipal League. All yeas, motion carried.


Imler and Ausra will continue to be Council members on the Volunteer Fire Fighter Dependent Fund Board for 1988.
