

BROOKVILLE MUNICIPAL COUNCIL  
REGULAR MEETING  
OCTOBER 20, 1987

The regular meeting of the Brookville Municipal Council was called to order by Mayor Brown at 7:30 P.M. on October 20, 1987 in the Municipal Council Chambers. Members Duncan, Garber, Imler, Keener, and Seagraves: Manager Wright and Law Director Zuhl were present. Member Ausra was absent.

Motion by Seagraves, seconded by Imler to accept the Agenda as presented with additions. All yeas, motion carried.

Motion by Duncan, seconded by Imler to approve the October 6, 1987 regular meeting minutes as presented. All yeas, motion carried.

Citizens Comments: 1) Forest Swift with R.T.A. gave a presentation on the operation and plans of R.T.A. Discussion followed. 2) Charles Haught with Tri-City Engineers presented updated plans on proposed Wolf Run subdivision and asked for approval of Council, subject to the Municipal Manager and Engineer approval, after they had time to go over complete plans. Discussion followed.

Motion by Seagraves, seconded by Duncan to table action on proposed Wolf Run subdivision plans until next meeting and the Municipal Manager and Engineer have a chance to check over plans and costs on changing Wolf Creek Pike and give their recommendations. All yeas, motion carried.

Manager Wright gave his report with no action taken, but gave an update on several items.

Mayor Brown gave his report with no action taken.

Motion by Imler, seconded by Seagraves to read proposed Ordinance No. 1987-09. All yeas, motion carried.

Motion by Duncan, seconded by Imler to accept the first reading, dispense with the second and third reading and adopt Ordinance No. 1987-09 entitled "AN ORDINANCE REPEALING SECTION 33.001 THRU 33.137 OF THE CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE, OHIO AND REPLACING THE SAME BY PROVIDING FOR THE DIRECTOR OF POLICE OF THE BROOKVILLE POLICE DEPARTMENT TO ADOPT VARIOUS DEPARTMENTAL RULES AND REGULATIONS FOR THE POLICE DEPARTMENT AND FURTHER PROVIDING FOR AN AUXILIARY POLICE DEPARTMENT AND DECLARING AN EMERGENCY." All yeas, motion carried.

Motion by Imler, seconded by Seagraves to read proposed Ordinance No. 1987-10. All yeas, motion carried.

Motion by Seagraves, seconded by Duncan to accept the first reading, dispense with the second and third reading and adopt Ordinance No. 1987-10 entitled "AN ORDINANCE REPEALING SECTION 34.10 THRU 34.18 OF THE CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE, OHIO AND REPLACING THE SAME BY PROVIDING FOR THE FIRE CHIEF OF THE FIRE DEPARTMENT OF BROOKVILLE, OHIO TO ADOPT VARIOUS DEPARTMENTAL RULES AND REGULATIONS FOR THE FIRE DEPARTMENT AND FURTHER PROVIDING FOR AN AUXILIARY FIRE DEPARTMENT AND DECLARING AN EMERGENCY. All yeas, motion carried.
