

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
SEPTEMBER 15, 1987

The regular meeting of the Brookville Municipal Council was called to order by Mayor Brown at 7:30 P.M. on September 15, 1987 in the Municipal Council Chambers. Members Ausra, Duncan, Garber, Imler, Keener and Seagraves; Manager Wright and Law Director Zuhl were present.

Motion by Seagraves, seconded by Imler to accept the Agenda as presented with the additions. All yeas, motion carried.

Motion by Imler, seconded by Duncan to approve the September 1, 1987 regular meeting minutes as presented. All yeas, motion carried.

Citizen Comments: Four citizens, Mrs. Howard as spokesman, had complaints about barking dogs in their area of Foothill Drive and Crosswell Avenue and etc. Discussion was held on the problem with consensus that they needed to call the police on the barking when it happens and the owner could be cited if it continues. The group is to report back to Council on whether calling the police was effective on solving the problem.

Manager Wright gave his report with the following action taken.

Motion by Seagraves, seconded by Imler to set "Beggars Night" on Thursday, October 29, 1987 from 6:00 P.M. to 8:00 P.M. which is in line with the same time as other subdivisions. All yeas, motion carried.

Motion by Duncan, seconded by Ausra to approve and authorize Manager Wright to sign the annexation petition for annexation of village property along South Wolf Creek Pike in front and across from the Sewer Plant as proposed. All yeas, motion carried.

Financial Director Roeser gave his report with the following action taken.

Motion by Seagraves, seconded by Imler to read proposed Resolution No. 87-20. All yeas, motion carried.

Motion by Imler, seconded by Duncan to accept the first reading, dispense with the second and third reading and adopt Resolution No. 87-20 entitled "A RESOLUTION ACCEPTING THE MONTGOMERY COUNTY BUDGET COMMISSION'S ALTERNATIVE METHOD OF DISTRIBUTING 1988 LOCAL GOVERNMENT FUNDS AND DECLARING AN EMERGENCY." All yeas, motion carried.

Motion by Duncan, seconded by Seagraves to accept the August 31, 1987 Fund Balances as presented. All yeas, motion carried.

Mayor Brown gave his report with the following action taken.

Read a Proclamation to proclaim the week of September 20, 1987 as "UNITED WAY WEEK."

Motion by Imler, seconded by Duncan to read proposed Ordinance No. 1987-07. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the first reading, dispense with the second and third reading and adopt Ordinance No. 1987-07 entitled "AN ORDINANCE ENACTING AND ADOPTING SUPPLEMENT NO. 8 TO THE CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE, OHIO, AND DECLARING AN EMERGENCY." All yeas, motion carried.

Motion by Duncan, seconded by Seagraves to read proposed Ordinance No. 1987-08. All yeas, motion carried.

Motion by Duncan, seconded by Seagraves to accept the first reading, dispense with the second and third reading and adopt Ordinance No. 1987-08 entitled "AN ORDINANCE TO PROVIDE ADDITIONAL NO PARKING ZONES ON STREETS WITHIN THE MUNICIPALITY OF BROOKVILLE, OHIO, SPECIFICALLY ON WOLF CREEK PIKE FROM MCKEEN LANE NORTH TO ARLINGTON ROAD ON BOTH SIDES OF THE ROADWAY AND ON ARLINGTON ROAD FROM RONA PARKWAY NORTH TO THE RAILROAD TRACKS ON BOTH SIDES OF THE ROADWAY AND DECLARING AN EMERGENCY." All yeas, motion carried.

Motion by Imler, seconded by Keener to adjourn. All yeas, motion carried.
