

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
MARCH 4, 1986

The regular meeting of the Brookville Municipal Council was called to order by Mayor Brown at 7:30 P.M. on March 4, 1986 in the Municipal Council Chambers. Members Ausra, Duncan, Garber, Imler, Keener and Seagraves; Manager Wright and Law Director Zuhl were present.

Motion by Duncan, seconded by Imler to accept the agenda as presented. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to approve the February 18, 1986 regular meeting minutes as presented. All yeas, motion carried.

Manager Wright gave his report with the following action taken.

Motion by Seagraves, seconded by Imler to authorize submitting application for grant from ODNR for the Fire Department in the amount of \$7,116.00 with possible maximum \$3,000.00 reimbursement. All yeas, motion carried.

Motion by Keener, seconded by Garber to accept the low bid of \$7,300.00 from Northwoods Construction Inc. for installation of handicap ramps, rails and etc. at the Municipal building entrances. All yeas, motion carried.

Mayor Brown gave his report with the following action taken.

Mayor Brown presented the \$2,500.00 check from Revenue Sharing funds to Dorothy Watkins who represents the Brookville Historical Society.

Motion by Seagraves, seconded by Imler to read proposed Ordinance No. 1985-17. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the third reading and adopt Ordinance No. 1985-17 entitled "AN ORDINANCE REZONING A CERTAIN LOT OF THE REVISED AND CONSECUTIVE NUMBERS OF LOTS OF THE MUNICIPALITY OF BROOKVILLE, OHIO FROM ITS PRESENT CLASSIFICATION OF R-1B TO THE NEW CLASSIFICATION OF R-2." All yeas, motion carried.

Mayor Brown administered the oath of office to Andrew Papanek as Director of Police.

Council was recessed for the Public Hearing on proposed rezoning Ordinance No. 1986-03 at 8:00 P.M.

Dennis Behnken and Frank Lucician presented plans for development of property at the corner of Albert and Brookville-Salem Roads which would require rezoning the property. Petition against the rezoning was presented by property owners. Many questions were asked and answers given with general discussion. Planning Commission went out to meet in order to give a recommendation.

Mayor Brown called Council back to order

Chairperson Watkins of the Planning Commission presented their recommendation that Council deny the proposed rezoning of property at the corner of Albert and Brookville-Salem Roads.

Motion by Ausra, seconded by Imler to read proposed Ordinance No. 1986-03.
All yeas, motion carried.

Motion by Duncan, seconded by Ausra to accept the second reading of proposed Ordinance No. 1986-03. All nays, motion failed.

Motion by Imler, seconded by Seagraves to read proposed Resolution No. 86-09.
All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the first reading, dispense with the second and third reading and adopt Resolution No. 86-09 entitled "A RESOLUTION FIXING THE COMPENSATION OF THE DIRECTOR OF POLICE AND DECLARING AN EMERGENCY." All yeas, motion carried.

Motion by Imler, seconded by Duncan to read proposed Resolution No. 86-10.
All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the first reading, dispense with the second and third reading and adopt Resolution No. 86-10 entitled "A RESOLUTION REQUESTING FEDERAL OFFICIALS TO NOT REDUCE OR ELIMINATE FEDERAL REVENUE SHARING PROGRAMS AND DECLARING AN EMERGENCY." Garber and Keener nays; Ausra, Brown, Duncan, Imler and Seagraves yeas, motion carried with 5 yeas and 2 nays.

Motion by Duncan, seconded by Seagraves to adjourn. All yeas, motion carried.
