

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
APRIL 2, 1985

The regular meeting of the Brookville Municipal Council was called to order by Mayor Brown at 7:30 P.M. on April 2, 1985 in the Municipal Council Chambers. Members Ausra, Imler, Keener, Seagrave and Weaver; Law Director Zuhl were present. Member Duncan, Manager Wright and Police Director Rose were absent.

Motion by Seagraves, seconded by Weaver to accept the agenda as presented. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to approve the March 19, 1985 regular meeting minutes as presented. All yeas, motion carried.

Citizen Comments: Dave Monnin in behalf of the Brookville Development Commission requested one parking space on each block from Wolf Creek to the railroad for handicapped parking and also the possible establishment of the downtown area as a historical area.

Motion by Imler, seconded by Weaver to establish one parking space per block on Market Street from Wolf Creek Street to the railroad for handicapped parking. All yeas, motion carried.

Ken Morgan requested that Council reconsider the "No Parking" on the west side of Columbia Street. Discussion held and to review decision.

Finance Director Roeser gave his report with the following action taken:

The Annual Report for 1984 is completed and Manager Wright will be happy to review the report at the next meeting and answer any questions.

Motion by Imler, seconded by Seagraves to read proposed Ordinance No. 1985-03. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the first reading of proposed Ordinance No. 1985-03. All yeas, motion carried.

Motion by Imler, seconded by Weaver to authorize signing the contract with the Brookville Historical Society concerning the \$2,500.00 grant out of the Federal Revenue Sharing Funds. All yeas, motion carried.

Motion by Imler, seconded by Weaver to accept the withdrawal of rezoning petition on proposed Ordinance No. 1985-02 as requested by letter from the applicant. All yeas, motion carried.

Council Meeting recessed at 8:00 P.M. for Public Hearing on proposed rezoning, one property owner present from letters sent. No objection received.

Council called back to order. Planning Commission's President Watkins reported that the Planning Commission recommended the change in zoning.

Motion by Imler, seconded by Ausra to read proposed Ordinance No. 1985-01. All yeas, motion carried.

Motion by Ausra, seconded by Imler to accept the second reading of proposed Ordinance No. 1985-01. All yeas, motion carried.


Mayor Brown gave his report with the following action taken:

Reported Youth-In-Government Week will be May 2, 3, 6 and 7.

Mayor Brown read Proclamation that April 20 through 27 will be "Clean Up Municipality of Brookville Week".

Motion by Imler, seconded by Seagraves to adjourn. All yeas, motion carried.
