

BROOKVILLE MUNICIPAL COUNCIL  
REGULAR MEETING  
APRIL 16, 1985

The regular meeting of the Brookville Municipal Council was called to order by Mayor Brown at 7:30 P.M. on April 16, 1985 in the Municipal Council Chambers. Members Ausra, Duncan, Imler, Keener, Seagraves and Weaver: Manager Wright, Law Director Zuhl and Police Director Rose were present.

Motion by Seagraves, seconded by Keener to accept the agenda as presented. All yeas, motion carried.

Motion by Ausra, seconded by Imler to approve the April 2, 1985 regular meeting minutes as presented. All yeas, motion carried.

Citizens Comments: Ken Morgan of the Lamplighter Inn and Jack Jenkins of Marilyn's Pizza on Market Street requested Council to reconsider the "No Parking" on the west side of Columbia Street and that more parking was needed plus problem of delivery vehicles for business. Neighbor of Lamplighter Inn complained about trash and etc. from the business and was in support of "No Parking" as being helpful for the area. Discussion followed on the problem, no changes made at the present time.

Dottie Watkins on behalf of the Chamber of Commerce requested the three hour parking be enforced in the central business district and that Council also consider putting handicapped parking on side streets.

Manager Wright gave his report with the following action taken:

Motion by Imler, seconded by Seagraves to contribute \$100.00 to the Ombudsman office for 1985. All yeas, motion carried.

Work session set following Council meeting.

Motion by Imler, seconded by Seagraves to authorize the Manager to proceed with the necessary steps for putting in sidewalk, curb and street improvements on the east side of Arlington Road along Golden Gate Park. All yeas, motion carried.

Law Director Zuhl gave his report with the following action taken:

Set 8:00 P.M. on May 21, 1985 for Public Hearing on rezoning the 706 through 718 Market Street properties with ordinance to be prepared for the next meeting.

Finance Director Roeser gave his report with the following action taken:

Motion by Imler, seconded by Duncan to accept the March 31, 1985 Fund Balance as presented. All yeas, motion carried.

Motion by Duncan, seconded by Imler to have the next Council meeting at 7:30 P.M. on May 7, 1985 at the High School. All yeas, motion carried.

Mayor Brown gave his report with the following action taken:

Presented Dottie Watkins, President of the Brookville Historical Society, a check for \$2500.00 that was granted the Historical Society out of Federal Revenue Sharing Fund by the Brookville Council.

Motion by Imler, seconded by Duncan to approve the date of May 12, 1985 at 11:00 A.M. and the parade route as requested for the Brookville Baseball Club opening day parade. All yeas, motion carried.

Motion by Keener, seconded by Imler to appoint Manager Wright to the Water Resource Technical Advisory Committee of the Miami Valley Regional Planning Commission. All yeas, motion carried.

Motion by Imler, seconded by Duncan to read proposed Ordinance No. 1985-01. All yeas, motion carried.

Motion by Imler, seconded by Ausra to accept the third reading and adopt Ordinance No. 1985-01 entitled "AN ORDINANCE REZONING CERTAIN LOTS OF THE REVISED AND CONSECUTIVE NUMBER OF LOTS OF THE VILLAGE OF BROOKVILLE, OHIO FROM THEIR PRESENT CLASSIFICATION TO THE NEW CLASSIFICATION OF B-3." All yeas, motion carried.


Motion by Imler, seconded by Seagraves to read proposed Ordinance No. 1985-03. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the second reading of proposed Ordinance No. 1985-03. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to read proposed Resolution No. 85-09. Keener nay; Ausra, Brown Duncan, Imler, Seagraves and Weaver yea, motion carried with 6 yeas and 1 nay.

Motion by Seagraves, seconded by Imler to accept the first reading of proposed Resolution No. 85-09. Keener nay; Ausra, Brown, Duncan, Imler, Seagraves and Weaver yea, motion carried with 6 yeas and 1 nay.
