

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
DECEMBER 17, 1985

The regular meeting of the Brookville Municipal Council was called to order by Mayor Brown at 7:30 P.M. on December 17, 1985 in the Municipal Council Chambers. Members Ausra, Duncan, Imler and Seagraves; and Manager Wright were present. Members Keener and Weaver; and Law Director Zuhl were absent.

Motion by Imler, seconded by Seagraves to accept the agenda as presented. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to approve the December 3, 1985 regular meeting minutes as presented. All yeas, motion carried.

Citizens Comments: Ralph Tucker and a group of citizens on March Avenue and Westbrook Road area presented a petition requesting size limitations and water drainage measures relating to construction of accessory buildings.
