

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
JULY 16, 1985

The regular meeting of the Brookville Municipal Council was called to order by Mayor Brown at 7:30 P.M. on July 16, 1985 in the Municipal Council Chambers. Members Ausra, Imler, Keener, Seagraves and Weaver; Manager Wright, Law Director Zuhl and Police Director Rose were present. Member Duncan was absent.

Motion by Seagraves, seconded by Imler to accept the agenda as presented. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to approve the July 2, 1985 regular meeting minutes as presented. All yeas, motion carried.

Manager Wright gave his report with the following action taken:

Motion by Imler, seconded by Weaver to approve parade route for Brookville Soccer Assoc. on September 7, 1985 at 9:00 A.M. of Carr Drive, Albert Road, Salem, Market, Wolf Creek and Golden Gate Park. All yeas, motion carried.

Motion by Seagraves, seconded by Ausra to accept the recommendation of Manager Wright to start street project this year to include Wolf Creek Pike from Westbrook Road to Arlington Road and Arlington Road from Westbrook Road to Wolf Creek. All yeas, motion carried.

Finance Director Roeser gave his report with the following action taken:

Motion by Imler, seconded by Seagraves to accept the June 30, 1985 Fund Balance as presented. All yeas, motion carried.

Consensus of Council was not to request a hearing before the Budget Commission on the 1986 Budget Hearing held August 5 and 6, 1985.

Mayor Brown gave his report with the following action taken:

Council asked that someone from Area Aging on aging be contacted to come to meeting with information on Brookville use of services.

Motion by Imler, seconded by Seagraves to read proposed Ordinance No. 1985-08. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the second reading of proposed Ordinance No. 1985-08. All yeas, motion carried.

Member Ausra had a request from the people on Mound Street for a block party.

Motion by Imler, seconded by Ausra to approve blocking of Mound Street from Brookside Drive to Orchard Street from 5:30 to 11:00 P.M. on August 8 or 9, 1985 for a block party. All yeas, motion carried.

Request by business people in the 200 block of Market Street to block street for various activities they were planning for promotion of downtown area.

Motion by Imler, seconded by Ausra to approve blocking the 200 block of Market Street from Waco Station to Mulberry Street from 1:00 to 10:00 P.M. on August 10, 1985 for downtown promotion activities. All yeas, motion carried.

Public Hearing 8:00 P.M. on proposed closing of alley on Ordinance No. 1985-08. Letter sent to railroad with no reply and no objection received. Resumed Council meeting.

Motion by Imler, seconded by Seagraves to adjourn. All yeas, motion carried.
