

BROOKVILLE MUNICIPAL COUNCIL  
REGULAR MEETING  
MAY 7, 1985

The regular meeting of the Brookville Municipal Council was called to order by Mayor Brown at 7:30 P.M. on May 7, 1985 in the High School Auditorium. Members Ausra, Duncan, Imler, Keener, Seagraves and Weaver; Manager Wright, Law Director Zuhl, Police Director Rose and Fire Director Dafler were present.

Mayor Brown recognized the co-founders of the Youth-In-Government Program and stated this makes the tenth year of a highly successful program. The meeting was turned over to the Youth-In-Government Council after they were introduced.

Motion by Imler, seconded by Seagraves to accept the agenda with addition and approve the April 16, 1985 regular meeting minutes as presented. All yeas, motion carried.

Manager Wright gave his report with no action taken.

Law Director Zuhl gave his report with no action taken.

Finance Director Roeser gave his report with the following action taken:

Motion by Imler, seconded by Seagraves to accept the April 30, 1985 Fund Balances as presented. All yeas, motion carried.

Firemen Director Dafler gave his report with no action taken.

Police Director Rose gave his report with no action taken.

Mayor Brown gave his report with the following action taken:

Read Proclamation to proclaim the month of May as Ohio Historic Preservation Month in Brookville.

Citizen Comments:

Chris West gave a presentation from the floor opposing relocation of Diamond Mill Road in Perry Township and asked for Council to endorse Plan B for Sycamore State Park.

Joe Gordon requested that three hour parking be extended on Mulberry Street from the alley to Hay Avenue on both sides of the street in front of the Brookville Star.

Motion by Imler, seconded by Seagraves to have Law Director prepare an ordinance for the next meeting to make requested area a three hour parking zone. All yeas, motion carried.

Joe Gordon presented maps with three various areas proposed for annexation to Brookville and requested Council's input before the group passed a petition for annexation.

Manager Wright reported that a meeting concerning Diamond Mill Road would be held in Trotwood on May 21, 1985 at 5:30 P.M.

Ruth Ann Strawbsburg of Perry Township spoke opposing the relocation of Diamond Mill Road.

Mr. Reed thanked Council officials and employees of the Municipality for another successful Youth-In-Government Program.

Motion by Imler, seconded by Duncan to read proposed Ordinance No. 1985-03. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the third reading and adopt Ordinance No. 1985-03 entitled "AN ORDINANCE AMENDING THE CODE OF ORDINANCES TITLE 5, SECTION 52.10, PAR. A - AN ORDINANCE FIXING THE RATES AND CHARGES TO ALL REFUSE CUSTOMERS IN THE MUNICIPALITY OF BROOKVILLE, OHIO." All yeas, motion carried.

Motion by Imler, seconded by Seagraves to read proposed Resolution No. 85-09. Keener nay; Ausra, Brown, Duncan, Imler, Seagraves and Weaver yeas, motion carried with 6 yeas and 1 nay.

Motion by Seagraves, seconded by Imler to accept the second reading of proposed Resolution No. 85-09. Keener nay; Ausra, Brown, Duncan, Imler, Seagraves and Weaver yeas, motion carried with 6 yeas and 1 nay.

Motion by Seagraves, seconded by Imler to read proposed Resolution No. 85-10. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the first reading, dispense with the second and third reading and adopt Resolution No. 85-10 entitled "A RESOLUTION FIXING THE COMPENSATION OF THE DIRECTOR OF POLICE AND DECLARING AN EMERGENCY." All yeas, motion carried.

Motion by Imler, seconded by Seagraves to read proposed Ordinance No. 1985-04. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the first reading of proposed Ordinance No. 1985-04. All yeas, motion carried.

Mayor Brown announced that the Public Hearing would be on May 21, 1985 at 8:00 P.M. on rezoning petition.

Mayor Brown presented certificates to the Youth-In-Government officials for their part in the program.

Councilman Duncan asked that a swimming pool committee be formed to look into means for a Municipal Pool.

Mayor Brown appointed Duncan to head a pool committee and he should select others to help him on the committee.

Motion by Imler, seconded by Ausra to adjourn. All yeas, motion carried.
