

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
OCTOBER 15, 1985

The regular meeting of the Brookville Municipal Council was called to order by Mayor Brown at 7:30 P.M. on October 15, 1985 in the Municipal Council Chambers. Members Duncan, Imler, Keener, Seagraves and Weaver; Manager Wright, Law Director Zuhl and Police Director Rose were present. Member Ausra was absent.

Motion by Duncan, seconded by Seagraves to accept the agenda as presented with changes. All yeas, motion carried.

Motion by Seagraves, seconded by Weaver to approve the October 1, 1985 regular meeting minutes as presented. All yeas, motion carried.

Citizens Comments: Susan Turner and Vicky Rauch made a presentation regarding the Handivan Program for Senior Citizens & Handicapped being run by Trinity Lutheran Church. Present timeserving approximately 30 people in Brookville School District. Need \$2,600 total for first year of operation which ends in May to pay for replacement cost of handivan. Discussion, but no action, will consider later.

Manager Wright gave his report with no action taken. No bids were received on ramp project for the Municipal building.

8:00 P.M. Public Hearing on proposed Ordinance No. 1985-11 with discussion and questions from citizens. Questions on what ordinance consisted of were answered and what fees for permits should be charged. Hearing over and Council called back to order.

Motion by Imler, seconded by Seagraves to amend proposed Ordinance No. 1985-11 by adding permit fee of \$15 for zoning compliance review and inspection. All yeas, motion carried.

Motion by Duncan, seconded by Seagraves to read proposed Ordinance No. 1985-11 as amended. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the first reading of proposed Ordinance No. 1985-11. All yeas, motion carried.

Finance Director Roeser gave his report with the following action taken.

Motion by Seagraves, seconded by Imler to prepare Ordinance and Agreement to accept Brookville C.I.C. as its agency for industrial, commercial, distribution and research development. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to not request a hearing on permit transfer from Applegate to Malone at 710 Market Street by the Ohio Dept. of Liquor Control. All yeas, motion carried.


Motion by Seagraves, seconded by Imler to accept the September 30, 1985 Fund Balance as presented. All yeas, motion carried.

Mayor Brown gave his report with the following action taken.

October 31, 1985 from 6:00 to 8:00 P.M. was set as Beggar's Night.

Motion by Imler, seconded by Seagraves to adjourn. All yeas, motion carried.
