

BROOKVILLE MUNICIPAL COUNCIL  
REGULAR MEETING  
SEPTEMBER 3, 1985

The regular meeting of the Brookville Municipal Council was called to order by Mayor Brown at 7:30 P.M. on September 3, 1985 in the Municipal Council Chambers. Members Ausra, Duncan, Imler, Keener, Seagraves, and Weaver; Manager Wright and Law Director Zuhl were present. Police Director Rose was absent.

Motion by Seagraves, seconded by Imler to accept the agenda as presented. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to approve the August 20, 1985 regular meeting minutes as presented. All yeas, motion carried.

Citizen Comments: Complaint on disturbances at nights on JoAnna Street.

Manager Wright gave his report with the following action taken.

Motion by Seagraves, seconded by Weaver to accept the Arena Dodge, Inc. bid of \$11,399.77 for a 1986 police crusier as the best bid due to it being for a 1986 instead of the 1985 model the low bid was for. All yeas, motion carried.

Motion by Seagraves, seconded by Imler to return and not request a hearing on either the new permit application or the transfer application to the Ohio Department of Liquor Control that were received. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to read proposed Ordinance No. 1985-09. All yeas, motion carried.

Motion by Seagraves, seconded by Duncan to accept the first reading, dispense with the second and third reading and adopt Ordinance No. 1985-09 entitled "AN ORDINANCE APPROVING VARIOUS AMENDMENTS MADE TO THE CODIFICATION OF THE ORDINANCE OF THE MUNICIPALITY OF BROOKVILLE, OHIO, ADDING NEW MATTER REPEALING VARIOUS ORDINANCES AND DECLARING AN EMERGENCY". All yeas, motion carried.

Motion by Imler, seconded by Duncan to read proposed Ordinance No. 1985-10. All yeas, motion carried.

Motion by Duncan, seconded by Seagraves to accept the first reading, dispense with the second and third reading and adopt Ordinance No. 1985-10 entitled "AN ORDINANCE TO PROVIDE ADDITIONAL STOP STREETS WITHIN THE MUNICIPALITY OF

BROOKVILLE BY MEANS OF ADDING STOP SIGNS OR RELOCATING STOP SIGNS AND DECLARING AN EMERGENCY". All yeas, motion carried.
