

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
SEPTEMBER 17, 1985

The regular meeting of the Brookville Municipal Council was called to order by Mayor Brown at 7:30 P.M. on September 17, 1985 in the Municipal Council Chambers. Members Duncan, Imler, Keener, Seagraves and Weaver; Manager Wright, Law Director Zuhl and Police Director Rose were present. Member Ausra was absent.

Motion by Seagraves, seconded by Imler to accept the agenda as presented. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to approve and September 3, 1985 regular meeting minutes as presented. All yeas, motion carried.

Citizens Comments: Several citizens and business people from the Market Street area were present with complaint on problems in the Municipal Parking lot consisting of damage to vehicles, broken bottles, drinking, safety for women and girls and also problems along Market Street. Discussion on problems and possible stepped up patrolling in problem area.

Citizen complaint about how he was being informed by the police about his dog barking when they received complaint. Discussion.

Manager Wright gave his report with the following action taken:

Reported on two bids received for lift station at sewer plant, but tabled any action for more study.

Reported on annexation hearing held with input from two council members and Law Director who were also at the hearing.

Motion by Imler, seconded by Keener to read proposed Resolution No. 85-13. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the first reading, dispense with the second and third reading and adopt Resolution No. 85-13 entitled "A RESOLUTION CONFIRMING THAT THE MUNICIPALITY OF BROOKVILLE, OHIO SHALL PROVIDE A LEVEL OF SERVICE TO ALL AREAS ANNEXED INTO THE MUNICIPALITY OF BROOKVILLE, OHIO, EQUAL TO THAT PRESENTLY PROVIDED TO ALL AREAS CURRENTLY WITHIN THE CORPORATE LIMITS OF THE MUNICIPALITY OF BROOKVILLE, OHIO, AND DECLARING AN EMERGENCY." All yeas, motion carried.

Finance Director Roeser gave his report with the following action taken:

Motion by Imler, seconded by Duncan to accept the August 31, 1985 Fund Balance as presented. All yeas, motion carried.

Mayor Brown gave his report with the following action taken:

Council will interview applicants for Board of Appeals at 6:45 P.M. on October 1, 1985.

Member Weaver reported on Legislative Committee of M.V.R.P.C.

Member Duncan reported on Recreation Committee.

Motion by Imler, seconded by Seagraves to read proposed Ordinance No. 1985-12. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to accept the first reading dispense with the second and third reading and adopt Ordinance No. 1985-12 entitled "AN ORDINANCE TO IMPOSE NO ON-STREET PARKING FOR CARR DRIVE NORTH AND CARR DRIVE SOUTH AND DECLARING AN EMERGENCY". All yeas, motion carried.

Public Hearing set for 8:00 P.M. on October 15, 1985 for proposed Ordinance No. 1985-11 regarding dish type collectors and/or mish type free standing structure.

Motion by Imler, seconded by Seagraves to adjourn. All yeas, motion carried.
