

BROOKVILLE MUNICIPAL COUNCIL
REGULAR MEETING
DECEMBER 4, 1984

The regular meeting of the Brookville Municipal Council was called to order by Mayor Brown at 7:30 P.M. on December 4, 1984 in the Municipal Council Chambers. Members Ausra, Imler, Keener, Seagraves and Weaver; Manager Wright, Law Director Zuhl and Police Director Rose were present.

Manager Wright asked for an executive meeting concerning wages to follow the Council Meeting.

Motion by Seagraves, seconded by Imler to accept the agenda as presented. All yeas, motion carried.

Motion by Imler, seconded by Seagraves to approve the November 20, 1984 regular meeting minutes as presented. All yeas, motion carried.

Citizen Comments: Manager Wright asked Mr. Studebaker to tell Council of his parking problem on Sycamore Street by his property on the corner of Sycamore and Hay. Discussion followed on the problem concerning parking, too close to overhead door to get in and out. No action taken, but will repaint yellow curb properly and enforce more closely.

Jerry Leiber inquired about using some brick and leaving a place for trees in front of his building on Market when he replaces sidewalk. Would not meet with the present requirement and after some discussion the Mayor and Manager will meet with him and try to come back with a proposal to Council.

Bob Wright and Ed Dean of VFW Post 3288 presented certificates to Patrolman Ed Preston and Tom McCauley from the VFW recognizing them for their outstanding service in their field.

Finance Director Roeser gave his report with the following action taken:

Motion by Imler, seconded by Seagraves to authorize the Manager to sign an agreement with C. E. Dice Electric Service to continue doing electrical inspections and adopting the rate schedule as on Exhibit A that is attached to the agreement. All yeas, motion carried.

Mayor Brown gave his report with the following action taken:

Motion by Seagraves, seconded by Imler to declare Apgar's Council position vacant as of December 1, 1984 due to accepting his resignation at the previous Council meeting. All yeas, motion carried.

Motion by Ausra, seconded by Imler to advertise for the Council position and accept applications in writing up to the December 18, 1984 Council meeting for the position. All yeas, motion carried.

Council meeting recessed for a Public Hearing on vacating an alley in back of properties on Hay Avenue. 8:00 P.M.

There were no objections on vacating the alley and no apparent use to the Village. Discussion was held on vacating the alley and also on paying for the costs involved for the engineer and etc. It was the con-

The Public Hearing was over and Council was called back in session.

Motion by Ausra, seconded by Seagraves to authorize prepairing and ordinance to vacate the alley for the next meeting and that the cost involved in the vacating should be charged to the property owners and paid before the third reading of the ordinances. All yeas, motion carried.

Motion by Imler, seconded by Keener to adjourn. All yeas, motion carried.
