The regular meeting of the Brookville Municipal Council was called to order by Mayor Brown at 7:30 P.M. on July 3, 1984 in the Municipal Council Chambers. Members Apgar, Ausra, Imler, Keener, Seagraves and Weaver; Manager Wright and Police Director Rose were present. Law Director Zuhl was absent.

Motion by Imler, seconded by Ausra to approve the June 19, 1984 regular meeting minutes as presented. All yeas, motion carried.

Manager Wright gave his report with the following action taken.

Motion by Apgar, seconded by Weaver to table any action on angled parking versus parallel parking concerning possible problem in the courts or circles within the Corporation. All yeas, motion carried.

Motion by Apgar, seconded by Imler to read proposed Ordinance No. 1984-06. All yeas, motion carried.

Motion by Apgar, seconded by Imler to accept the first reading, dispense with the second and third readings and adopt Ordinance No. 1984-06 entitled "AN ORDINANCE AMENDING SECTION 52.10 OF THE CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE, OHIO, BY ESTABLISHING A CHARGE FOR COMMERCIAL BUSINESS FOR THE COLLECTION OF TIRES BY THE MUNICIPALITY AND DECLARING AN EMERGENCY." All yeas, motion carried.

Finance Director Roeser gave his report with no action taken.

Mayor Brown gave his report with no action taken.

Motion by Imler, seconded by Apgar to read proposed Resolution No. 84-05. All yeas, motion carried.

Motion by Apgar, seconded by Imler to accept the second reading of proposed Resolution No. 84-05. All yeas, motion carried.

8:00 P.M. Public Hearing on the 1985 Budget including the Revenue Sharing Fund and the proposed uses of the Federal Revenue Sharing funds. There were eight (8) citizens present concerning the use of Federal Revenue Sharing Funds with two (2) presentation made to Council requesting some funding. Presentation was made for the Brookville Historical Society and written request for funds presented. Discussion followed. Motion by Apgar, seconded by Imler to grant \$2,500 of the 1985 Federal Revenue Sharing Fund to the Brookville Historical Society Inc. as requested. All yeas, motion carried.

Motion by Apgar, seconded by Imler to waiver water tap-in charge of \$200 for Brookwood Center Inc. property. All yeas, motion carried.

Motion by Apgar, seconded by Imler to grant \$2,500 of the 1985 Federal Revenue Sharing Funds to Brookwood Center Inc. as requested provided this is permitted after checking with the Auditor. All yeas, motion carried.

Balance of the Federal Revenue Funds will be used for streets as in the past.


Finance Director Roeser went over the entire proposed 1985 budget including the Federal Revenue Sharing Fund. Discussion followed.
