The regular meeting of the Brookville Municipal Council was called to order by Mayor Brown at 7:30 P.M. on June 19, 1984 in the Municipal Council Chambers. Members Apgar, Ausra, Imler, Keener, and Weaver; Manager Wright and Law Director Zuhl were present. Member Seagraves and Police Director Rose were absent.

Motion by Imler, seconded by Apgar to accept the agenda as presented. All yeas, motion carried.

Motion by Imler, seconded by Apgar to approve the June 5, 1984 regular meeting minutes as presented. All yeas, motion carried.

Citizens Comments: 1) Kathy Shannon from G. T. E. was present and answered some questions about telephone service and will be coming to some Council meeting as a public service. 2) Mr. Shochley voiced a complaint on receiving parking tickets parked in front of his property which is on a circle and has parked the same way for twenty years. Manager Wright to look into the complaint. 3) Dottie Watkins on behalf of the sorority request use of the streets for a road race in October.

Motion by Apgar, seconded by Imler to approve use of the necessary streets by the sorority for White Rose Race on October 28, 1984 in the afternoon. All yeas, motion carried.

Dottie Watkins on behalf of the Brookville Historical Society gave a brief history and some facts on the museum and requested \$2,500 from the Federal Revenue Sharing for use on the museum.

Manager Wright gave his report with the following action taken.

Motion by Apgar, seconded by Imler to authorize the Manager to advertise for a new body for the Fire Department's rescue truck to be put on the present truck. All yeas, motion carried.

Motion by Apgar, seconded by Ausra to prepare and Ordinance to charge for picking up old tires from commercial businesses served by the Refuse Department, but not residential customers. All yeas, motion carried.

Law Director Zuhl gave his report and requested a work session following the Council Meeting.

Finance Director Roeser gave his report with the following action taken.

Public Hearing set for July 3, 1984 at 8:00 P.M. on the 1985 Budget including Federal Revenue Sharing and its proposed uses.

Motion by Apgar, seconded by Imler to read proposed Resolution No. 84-05 with changes added. All yeas, motion carried.

Motion by Apgar, seconded by Imler to accept the first reading of proposed Resolution No. 84-05. All yeas, motion carried.

Mayor Brown gave his report with the following action taken.

Motion by Ausra, seconded by Weaver to authorize a letter of Council and Mayor's support of the Trotwood Connector be drafted and sent to Trotwood. Keener nay; Apgar, Ausra, Brown, Imler and Weaver yea, motion carried with 5 yeas and 1 nay.

Member Apgar reported on the Development Commission's informal get together with the business people on June 27 at the VFW Post and that Council members were welcome also.

Motion by Imler, seconded by Apgar to adjourn. All yeas, motion carried.
