The regular meeting of the Brookville Municipal Council was called to order by Mayor Apgar at 7:30 P.M. on April 5, 1983 in the Municipal Council Chambers. Members Brown, Imler, Keener and Weaver; Manager Wright, Law Director Zuhl and Police Director Rose were present. Members Ausra and Dean were absent.

Motion by Imler, seconded by Keener to approve the March 15, 1983 regular meeting minutes as presented. All yeas, motion carried.

Citizen Comments: Complaint from resident on Columbia Street extension, discussion followed and Manager will look into the problem.

Manager Wright gave his report with the following action taken.

Motion by Brown, seconded by Imler to read proposed Resolution #83-04. All yeas, motion carried.

Motion by Weaver, seconded by Imler to accept the first reading of proposed Resolution #83-04. All yeas, motion carried.

Manager Wright will advertise for a Building and Zoning Code Inspector.

Finance Director Roeser gave his report with the following action taken.

Motion by Imler, seconded by Weaver to recind motion of January 4, 1983 and January 18, 1983 concerning paying \$765.00 to the Montgomery County Council on Aging and not pay anything due to lack of positive action by the Council on Aging toward local Senior Citizens Group. All yeas, motion carried.

Mayor Apgar gave his report with the following action taken.

Proclaimed the week of April 11 through 17, 1983 as 4-H Awareness Week; May 1, 1983 as Loyalty Day; Week of May 8, 1983 as Small Business Week; and Week of April 17 through 23, 1983 as Volunteer Recognition Week.

Mayor Apgar discussed Disaster Plan to be developed.

8:00 P.M. a public hearing was held on proposed Ordinance #1983-03 requirements concerning Adult Entertainment facilities. Discussion followed.

Recessed meeting for Planning Commission to meet and come back with a recommendation to Council on proposed ordinance.

Mayor Apgar called Council meeting back to order and the Planning Commission presented their recommendations that the ordinance be passed with amendment that Section III, Paragraph 9 be changed from B-1 or B-2 to B-4 for parking and similar use standards and that all members present were in favor.

Motion by Brown, seconded by Imler to read proposed Ordinance #1983-03. All yeas, motion carried.

Motion by Imler, seconded by Weaver to amend proposed Ordinance #1983-03 as recommended by the Planning Commission and accept the second reading as amended. All yeas, motion carried.

Member Weaver gave report on M.V.R.P.C. meeting with no action taken.

Motion by Brown, seconded by Keener to read proposed Ordinances #1983-02; #1983-04; #1983-05; and #1983-06. All yeas, motion carried.

Motion by Imler, seconded by Weaver to amend proposed Ordinance #1983-02 by adding "providing that the drainage ditch is not rechanneled" and accept the second reading as amended. All yeas, motion carried.

Motion by Brown, seconded by Keener to accept the second reading of proposed Ordinance #1983-04; #1983-05; and #1983-06. All yeas, motion carried.
