The regular meeting of the Brookville Municipal Council was called to order by Mayor Apgar at 7:30 P.M. on August 3, 1983 in the Municipal Council Chambers. Members Ausra, Imler and Keener; Manager Wright, Law Director Zuhl and Police Director Rose were present. Members Brown, Dean and Weaver were absent.

Motion by Imler, seconded by Keener to approve the July 19, 1983 regular meeting minutes as presented. All yeas, motion carried.

Citizen Comments: Clerk Roeser reported that Nancy Cooper, a citizen, at 227 McKinley, requested help on parking problem and/or being able to turn into her driveway and being able to load a handicapped person in and out during the day. This was turned over to Police Director Rose to check whether the people parking too close to driveway were causing the problem.

Manager Wright gave his report with the following action taken.

Motion by Imler, seconded by Apgar to accept the Golden Giant Inc. bid of \$23,410 on the 50' X 60' steel building for equipment storage as the best bid. All yeas, motion carried.

Law Director Zuhl gave his report with the following action taken.

Motion by Imler, seconded by Ausra to table the the third reading of proposed Ordinance #1983-17. All yeas, motion carried.

Mayor Apgar gave his report with no action taken.

Member Imler read minutes of the special Planning Commission meeting.

Motion by Imler, seconded by Keener to read proposed Ordinance #1983-11 thru #1983-16 and proposed Resolutions #83-08 and #83-09. All yeas, motion carried.

Motion by Imler, seconded by Apgar to accept the third readings and adopted Ordinance #1983-11 entitled "AN ORDINANCE AMENDING SECTION 150.012 (C) OF THE CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE, OHIO"; Ordinance #1983-12 entitled "AN ORDINANCE ESTABLISHING A REQUIREMENT OF FILING FOR A SWIMMING POOL PERMIT PRIOR TO THE CONSTRUCTION OF ANY SWIMMING POOL WITHIN THE LIMITS OF THE MUNICIPALITY OF BROOKVILLE, OHIO"; Ordinance #1983-13 entitled "AN ORDINANCE AMENDING SECTION 150.195 (A) BY INCREASING THE FEE FOR EACH APPLICATION FOR A VARIANCE OR EXCEPTION"; Ordinance #1983-14 entitled "AN ORDINANCE AMENDING SECTION 150.213 OF THE CODE OF ORDINANCES BY CREATING A FEE FOR THE APPLICATION OF A CERTIFICATE OF ZONING COMPLIANCE"; Ordinance #1983-15 entitled "AN ORDINANCE AMENDING SECTION 150.052(A)(2) AND (C) (1)"; Ordinance #1983-16 entitled "ORDINANCE ESTABLISHING A REQUIREMENT OF FILING FOR A WALL AND FENCE PERMIT PRIOR TO THE CONSTRUCTION OF A WALL AND/OR FENCE WITHIN THE LIMITS OF THE MUNICIPALITY OF BROOKVILLE, OHIO"; Resolution #83-08 entitled "A RESOLUTION ESTABLISHING A SCHEDULE OF ASSESSMENT FOR FENCE OR WALL PERMITS, SWIMMING POOL PERMITS, AND FOR TEMPORARY USE PERMITS"; and Resolution #93-09 entitled "A RESOLUTION ESTABLISHING A SCHEDULE OF FEES, CHARGES, AND EXPENSES PERTAINING TO THE SUBDIVISION CODE OF THE MUNICIPALITY OF BROOKVILLE, OHIO, PURSUANT TO SECTION 151.53 OF THE CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE, OHIO.
