The regular meeting of the Brookville Municipal Council was called to order by Mayor Apgar at 7:30 P.M. on March 15, 1983 in the Municipal Council Chambers. Members Brown, Dean, Imler, Keener, and Weaver; Manager Wright, Law Director Zuhl and Police Director Rose were present. Member Ausra was absent.

Motion by Imler, seconded by Dean to approve the March 1, 1983 regular meeting minutes as presented. All yeas, motion carried.

Citizens Comments resulted in the following:

Motion by Brown, seconded by Imler to authorize blocking streets as requested by Robert Wright in behalf of the V.F.W. for a parade route on April 30 at 11:00 A.M. running from Mosier's Industrial Park down Cusick to Market to Western ending at the High School with review stand in front of the church; also use of the Municipal Parking Lot from 3:00 to 12:00 Midnight for a dance. All yeas, motion carried.

Motion by Brown, seconded by Imler to authorize the Manager to have a traffic engineering study made at Triggs and Arlington Roads intersection and have recommendation brought back to Council. Brown, Imler, Weaver, Apgar yeas; Dean, Keener nays, motion carried with 4 yeas, 2 nays.

Manager Wright gave his report with the following action taken.

Motion by Dean, seconded by Imler to authorize the Manager to advertise for bids for the remodeling of the Senior Citizen's building at Golden Gate Park. All yeas, motion carried.

Law Director Zuhl gave his report with no action taken.

Finance Director Roeser gave his report with the following action taken.

Motion by Imler, seconded by Brown to accept the February 28, 1983 Fund Balance as presented. All yeas, motion carried.

Mayor Apgar gave his report with the following action taken.

Open House at the Municipal Building will be Sunday, March 20 from 1:00 P.M. to 4:00 P.M.

Youth-In-Government Week is April 27 through May 3 Council Meeting.

Motion by Imler, seconded by Dean to move the May 3, 1983 regular Council meeting to the Brookville High School. All yeas, motion carried.

Motion by Dean, seconded by Brown to draft a Resolution opposing the Goldwater Cable T.V. Bill which would severely cut back state and local authority regarding cable T.V. franchises. All yeas, motion carried.

Motion by Keener, seconded by Weaver to read proposed Ordinance No. 1983-03 through 1983-06. All yeas, motion carried.

Motion by Weaver, seconded by Keener to accept the first reading of proposed Ordinance No. 1983-03. All yeas, motion carried.

Motion by Dean, seconded by Imler to accept the first reading of proposed Ordinance No. 1983-04. All yeas, motion carried.

Motion by Imler, seconded by Apgar to accept the first reading of proposed Ordinance No. 1983-05. All yeas, motion carried.

Motion by Imler, seconded by Apgar to accept the first reading of proposed Ordinance No. 1983-06. Imler, Keener, Weaver, Apgar yeas; Brown and Dean nays, motion carried with 4 yeas, 2 nays.
