NOVEMBER 1, 1983

The regular meeting of the Brookville Municipal Council was called to order by Mayor Apgar at 7:30 P.M. on November 1, 1983 in the Municipal Council Chambers. Members Ausra, Brown, Dean, Imler and Keener; Manager Wright, Law Director Zuhl and Police Director Rose were present. Member Weaver was absent.

Motion by Imler, seconded by Keener to approve the October 18, 1983 regular meeting minutes as presented. All yeas, motion carried.

Citizen Comments: Coy Barnett and Waldo Keener of V.F.W. Post 3288 presented a certificate of appreciation for a job well done to Patrolman Matlock and Minniece and Sergeant Summers of the Brookville Police Department.

Superintendent Davison of Brookville Schools spoke on behalf of the tax levy, Issue 61, for the schools.

Motion by Brown, seconded by Imler that Council go on record in support of the passage of School Issue #61. All yeas, motion carried.

Motion by Brown, seconded by Imler that Council go on record opposing passage of State Issue #2 and #3. Ausra and Dean nay; Brown, Imler, Keener and Apgar yea, motion carried with 4 yeas and 2 nays.

Manager Wright gave his report with the following action taken: Announced that the new ambulance had been delivered. RTA wants to cut a bus route out that services Brookville and that there will be a hearing on this November 16, 1983 at noon and also 5:00 P.M. Hearing set for November 15, 1983 at 8:00 P.M. concerning U.D.A.G. Funds for possible project by a local business.

Executive session set for after Council meeting.

Law Director Zuhl gave his report with no action taken.

Finance Director Roeser gave his report with no action taken.

Mayor Apgar gave his report with the following action taken: Announced that November 1, 1983 would be the date for the Grand Opening of the Senior Citizen Building with the time to be announced later. Presented a Proclamation to proclaim November 13-19 as Youth Appreciation Week.

Tabled Material: Towing applications available as of tomorrow for anyone interested and it will be advertised in the paper. Forms are to be turned in by the next Council meeting.

Discussion was held on the Montgomery County Council on Aging as far as paying the requested amount. Concensus of the Council was they are not satisfied, as yet, as to a Brookville member of Senior Citizens being on County Council and information to the board group is not good.
