Minutes of BROOKVILLE MUNICIPAL COUNCIL

The regular meeting of the Brookville Municipal Council was called to order by Mayor Apgar at 7:30 P.M. on July 20, 1982 in the Municipal Council Chambers. Members Ausra, Brown, Imler, Keener and Weaver; Manager Wright and Law Director Zuhl were present. Member Dean arrived later.

Motion by Keener, seconded by Imler to approve the July 6, 1982 regular and July 13, 1982 special meetings as presented. All yeas, motion carried.

Manager Wright gave his report with the following action taken:

Note: Member Dean arrived at this time.

Motion by Imler, seconded by Brown to accept the low bid of \$60,945.00 from Miller Brothers and authorize the Finance Director to pay the balance of the project for the Goldern Gate Parking Lot out of the Park Fund and Capital Improvement Fund as necessary for the difference in the bid and the amount to be received from the County for the project. All yeas, motion carried.

Motion by Ausra, seconded by Weaver to have a Public ~~Hiring~~^{Meeting} at 8:00 P.M. on August 3, 1982 concerning Jackson Cable T.V. rate increase proposal to take effect September 1, 1982. All yeas, motion carried.

Law Director Zuhl gave his report with the following action taken.

Motion by Apgar, seconded by Brown to read proposed Ordinance #1982-11. Brown, Weaver, Keener, Apgar yea; Ausra, Dean, Imler nay, motion carried with 4 yeas, 3 nays.

Motion by Brown, second by Weaver to accept the first reading of proposed Ordinance #1982-11 entitled "AN ORDINANCE AMENDING ORDINANCE #33.013 OF THE CODE OF ORDINANCES OF THE MUNICIPALITY OF BROOKVILLE, OHIO BY REMOVING THE RESIDENCY REQUIREMENT CONTAINED THEREIN AND DECLARING AN EMERGENCY." Brown, Weaver, Apgar yea; Dean, Keener, Ausra, Imler nay, motion failed with 4 nays and 3 yeas.

Clerk-Finance Director Roeser gave his report with no action taken.

Mayor Apgar gave his report with the following action taken.

Motion by Dean, seconded by Imler to limit beer sales and consumption within the area designated: Jefferson St., Main St. (both sides), Mulberry St. (both sides), and the alleys between Market St. and Hay Ave. during times that permits are issued for on off premise sales for limited days. All yeas, motion carried.

Motion by Imler, seconded by Dean to adjourn. All yeas, motion carried.
