Minutes of BROOKVILLE MUNICIPAL COUNCIL

SEPTEMBER 21, 19 82

The regular meeting of the Brookville Municipal Council was called to order by Mayor Apgar at 7:30 P.M. on September 21, 1982 in the Municipal Council Chambers. Members Ausra, Brown, Dean, Imler, Keener and Weaver; Manager Wright and Law Director Zuhl were present.

Motion by Ausra, seconded by Imler to approve the September 7, 1982 regular meeting minutes as presented. All yeas, motion carried.

Citizens Comments: 1) Request that alley back of carryout be made one way for traffic. 2) Petition presented for street lights to be installed on Lisa Court and Poplar Street. 3) Citizen questioned the use of a municipal vehicle by an employee and complained of its being parked in front of the employee's property.

Manager Wright gave his report with the following action taken.

Discussion held on water problem on Cusick Avenue and possible correction measures mainly needed for new storm sewer to Wolf Creek. Problem needs more study and cost estimates.

Motion by Dean, seconded by Imler to authorize the Manager to enter in the County's contract bid agreement for de-icing salt for approximately 300 tons normal usage of \$25.63 per ton piled or \$24.63 per ton dumped. All yeas, motion carried.

Members of church wanting to build church on property along Wolf Creek Pike had questions on some of the requirements they needed to meet and asked about some relief from part of the requirements. Required to go to Planning Commission for recommendation.

Mayor Apgar gave his report with the following action taken.

Beggars Night was set for Saturday, October 30, 1982 from 6:00 to 8:00 P.M.

Member Brown gave report on the Planning Commission meeting and Member Dean gave report on the Park Board meeting.

Motion by Brown, seconded by Weaver to read proposed Ordinance #1982-12. All yeas, motion carried.

Motion by Brown, seconded by Keener to accept the second reading of proposed Ordinance #1982-12. Keener, Brown and Weaver yeas; Ausra, Dean, Imler and Apgar nays, 4 nays and 3 yeas motion failed.

Motion by Imler, seconded by Ausra to authorize blocking off Albert Road from Hay to Westbrook on Saturday, October 9, 1982 for the Bike-A-Thon. All yeas, motion carried.

Motion by Ausra, seconded by Keener to contribute \$25.00 to Daybreak as some Brookville youths have been helped by the organization. All yeas, motion carried.

Motion by Imler, seconded by Dean to adjourn. All yeas, motion carried.
