Minutes of BROOKVILLE MUNICIPAL COUNCIL

The regular meeting of the Brookville Municipal Council was called to order by Mayor Apgar at 7:30 P.M. on July 1, 1980 in the Municipal Council Chambers. Members Ausra, Bailey, Brown, Dean, Imler and Weaver; Manager Wright, Fire Chief Ullery were present. Police Director Jackson and Law Director Gowdown were absent.

Fire Chief Ullery gave a report on the Central Western Ohio Firemen's Convention held at West Milton and explained what the three 1st place trophies were for that the Brookville Department won at West Milton.

The June 17, 1980 regular meeting minutes were read and approved upon being properly signed.

Law Director Gowdown arrived.

Manager Wright gave his report with the following action taken. Motion by Imler, seconded by Dean to authorize the Manager to study the Water and Sewer rates and come back to Council with a recommendation on possible increases of rates needed to offset the increased costs and keep both funds in the black. All yeas, motion carried.

Law Director Gowdown gave his report with no action taken.

The 8:00 P.M. Public Hearing was opened on the Proposed 1981 Municipal Budget. Finance Director Roeser went over the proposed 1981 annual budget and answered the questions that were asked by the citizens and council.

Motion by Ausra, seconded by Imler to adopt the proposed budget for 1981 as presented. All yeas, motion carried.

Clerk-Finance Director Roeser gave his report with the following action taken.

Motion by Imler, seconded by Dean to accept the May 31, 1980 Fund Balance as presented. All yeas, motion carried.

Mayor Apgar gave his report with no action taken.

Motion by Ausra, seconded by Imler to read proposed Ordinance # 1980-8. All yeas, motion carried.

Motion by Ausra, seconded by Dean to accept the second reading of proposed Ordinance # 1980-8 entitled "AN ORDINANCE DECLARING A POLICY WITH REGARD TO RELATIONS WITH ORGANIZED EMPLOYEES OF THE MUNICIPALITY OF BROOKVILLE AND PROHIBITING STRIKES BY SUCH EMPLOYEES." Discussion followed on several points of the proposed ordinance brought up by Member Brown. Bailey, Brown and Weaver nay; Ausra, Dean, Imler and Apgar yea. Motion carried 4 yeas, 3 nays.

Mayor Apgar presented a petition he received from Brookville citizens stating that they requested the application for C-1 and C-2 Liquor License be rejected.

Motion by Ausra, seconded by Imler that Council object to this application and request a hearing with such hearing to be held in Montgomery County so that the local people can attend to voice their objections. Also that a copy of the petition presented to Council be attached to the form and sent to the Ohio Dept. of Liquor Control Bd. regarding the C-1 and C-2 permit requested for Brookville. All yeas, motion carried.

Motion by Imler, seconded by Dean to adjourn. All yeas, motion carried.
