JUNE 17, 1980

The regular meeting of the Brookville Municipal Council was called to order by Mayor Apgar at 7:30 P.M. on June 17, 1980 in the Municipal Council Chambers. Members Ausra, Bailey, Brown, Dean, Imler and Weaver; Manager Wright were present. Law Director Gowdown and Police Director Jackson were absent.

The June 4, 1980 regular meeting minutes were read and approved upon being properly signed.

Manager Wright gave his report with no action taken.

Clerk-Finance Director Roeser gave his report with the following action taken.

Motion by Apgar, seconded by Ausra to table the action until next meeting on a reply to the Ohio Dept. of Liquor Control concerning an application for a new C-1 & C-2 permit in Brookville. All yeas, motion carried.

The Public Hearing on the proposed 1981 Municipal Budget was set for 8:00 P.M. on July 1, 1980.

Mayor Apgar gave his report with no action taken.

Member Brown reported on the June 10, 1980 Park Board meeting, minutes are on file in the Clerk's Office.

Member Bailey gave a report on the TCC meeting she attended.

At 8:00 P.M. a Public Hearing was held on the Proposed Use of Revenue Sharing. Finance Director Roeser proposed continued use be for streets. No other proposed use was presented by citizen or council.

Police Director Jackson arrived and had no report.

Motion by Apgar seconded by Ausra to read proposed Ordinance #1980-8 in full. All yeas, motion carried.

Motion by Dean, seconded by Ausra to accept the first reading of proposed Ordinance #1980-8 entitled "AN ORDINANCE DECLARING A POLICY WITH REGARD TO RELATIONS WITH ORGANIZED EMPLOYEES OF THE MUNICIPALITY OF BROOKVILLE AND PROHIBITING STRIKES BY SUCH EMPLOYEES." Weaver, Bailey, Brown nay; Dean, Ausra, Imler, Apgar yea, motion carried with 4 yeas and 3 nays.

Motion by Ausra, seconded by Dean to post all proposed ordinances on the Municipal building hallway bulletin board after accepting the first reading and list which reading has passed. All yeas, motion carried.

Motion by Dean, seconded by Ausra to read proposed Ordinance #1980-4. All yeas, motion carried.

Motion by Dean, seconded by Imler to accept the third reading and adopt Ordinance #1980-4 entitled "AN ORDINANCE REZONING A PARCEL OF LAND KNOWN AS 510 SYCAMORE STREET, BROOKVILLE, OHIO AND LOCATED ON SYCAMORE STREET FROM B-4 TO I-1 OF THE ZONING ORDINANCE OF SAID MUNICIPALITY." All yeas, motion carried.

Motion by Apgar, seconded by Ausra to read proposed Ordinance #1980-7. All yeas, motion carried.

Motion by Imler, seconded by Bailey to accept the third reading and adopt Ordinance #1980-7 entitled "AN ORDINANCE AMENDING ORDINANCE NO. 433, SECTION II, BY INCREASING THE SCHEDULE OF RATES FOR TRASH AND GARBAGE COLLECTION SERVICE IN THE MUNICIPALITY OF BROOKVILLE, OHIO." All yeas, motion carried.

Motion by Imler, seconded by Ausra to read proposed Resolution #80-10. All yeas, motion carried.
