MAY 6, 1980

The regular meeting of the Brookville Municipal Council was called to order by Mayor Apgar at 7:30 P.M. on May 6, 1980 in the Municipal Council Chambers. Members Ausra, Bailey, Brown, Dean, Imler and Weaver; Manager Wright, Police Director Jackson, Fire Chief Ullery and Law Director Gowdown were present.

The April 15, 1980 regular meeting minutes were read and approved upon being properly signed.

Motion by Ausra, seconded by Imler to rescind the portion of a motion at the April 15, 1980 meeting by Ausra by deleting the following: "then have it done and present the verification results to Council. All contacts to be made before the next Council meeting". All yeas, motion carried.

Motion by Imler, seconded by Dean to change the June 3, 1980 regular meeting date to June 4, 1980 due to the election. All yeas, motion carried.

Mayor Apgar introduced the Youth-In-Government officials, presented certificates to each and also one to Mr. Reed. After various thanks and comments by different municipal officials the meeting was turned over to the students.

Citizens Comments: Dottie Watkins, representing the Chamber of Commerce, asked to have Market Street from the Village Butcher Shop to Waco Station and Mulberry Street and Market Street from alley to alley on each side of Market Street blocked off for the Brookville Historical Days and also various other streets on Sunday for the bike race route.

Motion by Imler, seconded by Dean to block-off the streets for the Historical Days as requested. All yeas, motion carried.

Manager Wright gave his report as follows: 1) Complete report on the work accomplished by the students in the past week. 2) Announced that the Community Block Grant was not approved.

Motion by Dean, seconded by Imler to have a work session on Tuesday, May 13, 1980 at 7:30 P.M. All yeas, motion carried.

Police Director Jackson gave his report on the police activities for the month of April. Announced that there would be an annual inspection of police personnel and equipment on May 17, 1980 at 1:00 P.M.

Police Director Jackson presented "Officer of the Month"certificates to Patrolman Hutton for April, Patrolman Bayot for March, Patrolman Summers for February and Patrolman Piper for January.

Director of Firemen Ullery gave his report with no action taken.

Law Director Gowdown gave his report with no action taken.

Mayor Apgar gave his report as follows: 1) Read Proclamation proclaiming the week beginning May 11, 1980 to be Nursing Home Week. 2) Read Proclamation proclaiming the week of May 11-17 to be Police Week.

Youth-In-Government Council, Mayor and Officials gave comments on their activities this past week.

Member Brown read the minutes of the April 8, 1980 Board of Park Trustees meeting which are on file in the Clerk's Office.

Member Bailey reported on the May 1, 1980 T.C.C. meeting.

Motion by Imler, seconded by Dean to read proposed Resolution #80-10. All yeas, motion carried. Clerk read proposed Resolution #80-10.

Motion by Imler, seconded by Apgar to read proposed Ordinance #1980-5 in full. All yeas, motion carried. Clerk read proposed Ordinance #1980-5.

Motion by Dean, seconded by Imler to table Written Motion #80-2 for further study. All yeas, motion carried.

Motion by Imler, seconded by Ausra to table Written Motion #80-3 for further study. All yeas, motion carried.

Motion by Imler, seconded by Ausra to read proposed Ordinance #1980-6 in full. All yeas, motion carried.

Motion by Dean, seconded by Imler to make proposed Ordinance #1980-6 an emergency due to protect the health, safety and welfare of minors under the age of fifteen years. All yeas, motion carried.

Motion by Brown, seconded by Weaver to amend Section #4 of proposed Ordinance #1980-6 to read as follows: "WHOEVER, UPON THE FIRST OFFENSE, VIOLATES SECTION I OR II SHALL BE SUBJECT TO A DOCUMENTED WRITTEN WARNING. WHOEVER, UPON A SECOND OR SUBSEQUENT OFFENSE VIOLATES SECTION I OR II SHALL BE GUILTY OF A MISDEMEANOR OF THE FOURTH DEGREE. WHOEVER, UPON THE FIRST OFFENSE VIOLATES SECTION III SHALL BE GUILTY OF A MINOR MISDEMEANOR. WHOEVER, UPON A SECOND OR SUBSEQUENT OFFENSE VIOLATES SECTION III SHALL BE GUILTY OF A MISDEMEANOR OF THE FOURTH DEGREE". All yeas, motion carried.

Motion by Ausra, seconded by Dean to dispense with the second and third reading and adopt Ordinance #1980-6 entitled "AN ORDINANCE ENACTING A CURFEW FOR MINORS UNDER THE AGE OF 15 YEARS WITHIN THE MUNICIPALITY OF BROOKVILLE, OHIO, AND DECLARING AN EMERGENCY." All yeas, motion carried.

Motion by Apgar, seconded by Dean to publish Ordinance #1980-6 in the local paper two times and not to enforce until seven days after the second publication. All yeas, except Brown who was absent, motion carried

Motion by Imler, seconded by Dean to adjourn. All yeas, motion carried.
